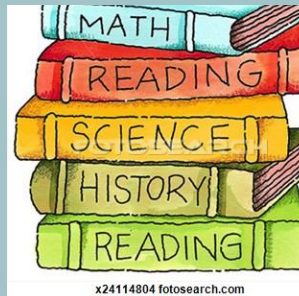
CSU East Bay prepares you to teach in an Elementary School

A **Multiple Subject Teaching Credential** typically used for elementary school classrooms, TK-5/6th grade depending on the school, authorizes the holder to teach in a self-contained classroom TK-12th grade.

In our Multiple Subject Credential program you will complete fieldwork in a TK-6th grade self-contained **ELEMENTARY** classroom, not in a middle school or high school.

This program is full-time, **in-person offered on Hayward or Concord campuses** with just a few classes online-begins in early June, completed in 3 semesters: Summer, Fall, Spring (one year) to complete.

- Summer Session 2024 is June 3 - July 26, 2024



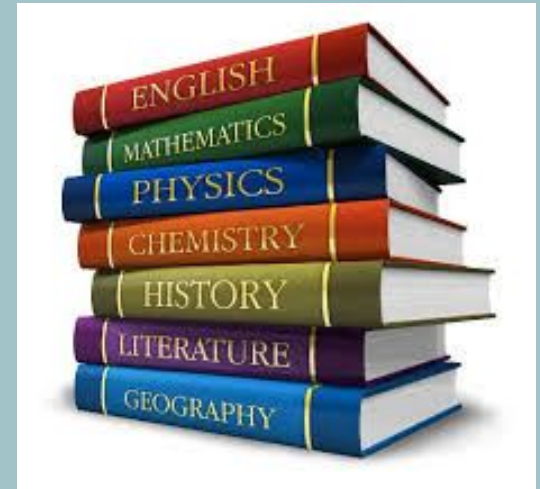
CSU East Bay prepares you to teach in a Middle or High School

A **Single Subject Teaching Credential** authorizes the holder to teach the specific subject named on the credential in departmentalized classes in the TK–12 classroom setting. Typically used in middle school and high school.

In our Single Subject Credential program you will be placed in a **MIDDLE** or **HIGH SCHOOL** classroom, completing fieldwork in your subject area. You cannot complete fieldwork outside of your subject area.

This program is full-time, also begins in early June, and takes 3 semesters (one year) to complete.

You may also be a departmentalized teacher for Art, Dance, Music, Physical Education, Science or World Languages in an elementary school setting.

CSU East Bay prepares you to work in a Special Education classroom

The **Preliminary Education Specialist Credential** authorizes the holder to conduct Educational Assessments related to students' access to the academic curriculum and progress towards meeting instructional academic goals. This is a two-year program that leads to recommendation of a credential and Masters of Science in Special Education. **All Classes are online. Fieldwork is in-person.**

Mild to Moderate Support Needs (MMSN)

Provide Special Education Support to students with mild to moderate support needs related to one or more of the following disabilities: autism, emotional disturbance, intellectual disability, multiple disabilities, orthopedic impairment, other health impairment, specific learning disability, and traumatic brain injury; in kindergarten, including transitional kindergarten, grades 1-12 through age 22.

Extensive Support Needs (ESN)

Provide Special Education Support to students with extensive support needs related to one or more of the following disabilities: autism, deaf, blind, emotional disturbance, intellectual disability, multiple disabilities, orthopedic impairment, other health impairment, specific learning disability, and traumatic brain injury; in kindergarten, including transitional kindergarten, grades 1-12 through age 22

- ❖ **Negative Tuberculosis (TB) Test** result from within the past two years
 - Upload a dated copy of healthcare providers results verifying negative TB from a test. **A TB risk assessment does not meet the requirement, it needs to be skin/blood test or a chest x-ray.**
 - TB skin & blood tests are good for 3 years or chest x-ray is good for 5 years.

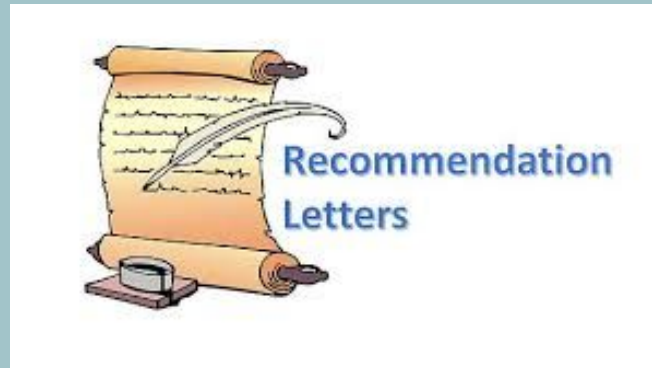
