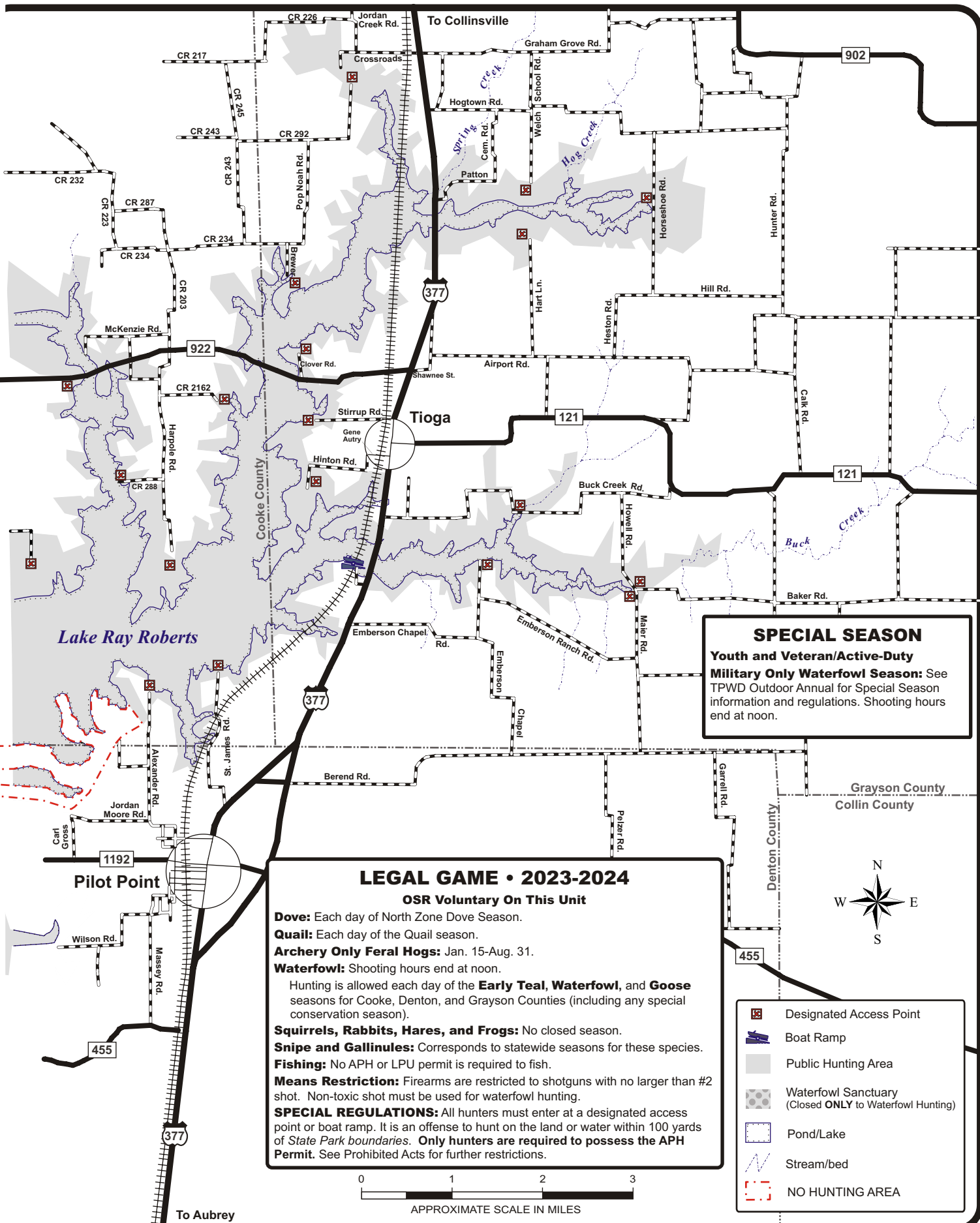

SPECIAL SEASON
Youth and Veteran/Active-Duty Military Only Waterfowl Season: See TPWD Outdoor Annual for Special Season information and regulations. Shooting hours end at noon.

LEGAL GAME • 2023-2024
OSR Voluntary On This Unit

Dove: Each day of North Zone Dove Season.
Quail: Each day of the Quail season.
Archery Only Feral Hogs: Jan. 15-Aug. 31.
Waterfowl: Shooting hours end at noon.
 Hunting is allowed each day of the **Early Teal, Waterfowl, and Goose** seasons for Cooke, Denton, and Grayson Counties (including any special conservation season).
Squirrels, Rabbits, Hares, and Frogs: No closed season.
Snipe and Gallinules: Corresponds to statewide seasons for these species.
Fishing: No APH or LPU permit is required to fish.
Means Restriction: Firearms are restricted to shotguns with no larger than #2 shot. Non-toxic shot must be used for waterfowl hunting.
SPECIAL REGULATIONS: All hunters must enter at a designated access point or boat ramp. It is an offense to hunt on the land or water within 100 yards of *State Park* boundaries. **Only hunters are required to possess the APH Permit.** See Prohibited Acts for further restrictions.
