Non-partisan voter registration program.

The North Carolina APRI Comprehensive Voter Registration Program concentrates its efforts on counties and precincts with high concentrations of African Americans, Native Americans, and rural areas inhabited by those disenfranchised by situation, circumstance or indifference that appear to be excluded from political empowerment. The goal of encouragement and expansion of black political activity was achieved.

4b (Code:) (Expenses \$ 98,000 including grants of \$ 95,000) (Revenue \$)

Non-partisan get-out-the-vote activity, voter education activity, and election protection program

This civic engagement program works to increase black participation in the political process. NCAPRI successfully operated Program Operations & Training Centers at Raleigh, Charlotte, Fayetteville, Roanoke Rapids, and Jacksonville, North Carolina. Centers expanded functionality beyond GOTV activity for use in voter education and election protection activity. The centers gave the disenfranchised a place that they could volunteer and give back to the community. Training for APRI members, volunteers, and staff included VAN, communications planning, get-out-the-vote planning, media relations, data entry, and new technology. Provided community education on the importance of civic engagement, community service and volunteerism to the community and benefits of having good public school education system. We also provided valuable information on the specific areas and people that still need hurricane relief assistance, and are working the communities preparing for future hurricanes.

Capacity building, community organizing, and youth leadership development program

Our program serves to identify young leaders, strengthen current leadership and support relationship building among NCAPRI leaders in order to increase the presence of trade unionists in the black community. The program serves to educate APRI members about national policies which have a direct impact on the black community. For example, in the past four years, NCAPRI has aggressively focused on health advocacy and healthcare reform to establish practices and implement programs, to insure that the issue of race-based healthcare disparities was placed squarely on the state's and nation's agenda. Our program also serves to build community support and educate the community around the issues of climate change, environmental justice, and green jobs. NCAPRI also works to develop black leadership in the trade union movement. Black leaders are important to the trade union movemet, to local communities and to our state and nation. Black labor leaders and community activists regularly turn to the Institute for training and networking contacts. APRI members serve in state legislatures, school boards, city councils, local and international unions and governmental and community leadership.
