Review of Relevant ORH Programs

- Provided background information on enrolled rural Veterans, history of Office of Rural Health, organizational functions, enterprise-wide initiatives, and functions of Veterans Rural Health Resource Centers.
- Discussed key enrolled rural women Veterans demographics and provided overview of ORH initiatives.

Presentation: Workforce Development

Jessica Bonjorni, Chief, Human Capital Management, U.S. Department of Veterans Affairs

- Discussed VHA workforce statistics – including rural employee statistics and demographic breakdown. Discussed turnover rates, facility growth, and workforce programs and strategies for rural facilities.
- Discussed workforce recruitment strategies and programs targeted at rural sites including loan repayment, scholarships, and salary and work schedule incentives.

Presentation: Supporting Rural Veteran Communities

- Provided overview of VHA Outpatient Survey data for rural Veterans and discussed questions and feedback solicited in surveys.
- Highlighted and discussed recent narrative feedback from rural Veterans in both the “compliment” and “concern” categories regarding mail order prescriptions and telehealth visits.

Panel Discussion: Education and Training Programs for Rural Women Veterans

- Discussed substance use disorders in rural areas and impact on women Veterans. Highlighted lack of specialty care in rural areas to treat substance use disorders.
- Discussed project work focused on analyzing primary care services in context of MISSION Act, rural Veteran access to Community Based Outpatient Clinics (CBOCs) and non-VA primary care clinics, and barriers non-VA primary care clinics face in becoming MISSION Act providers.

Dr. Carolyn Turvey, Clinical Director, Office of Rural Health Veterans Rural Health Resource Center – Iowa City, Iowa

- Reviewed purpose, goals, and outcomes of Rural Quality Scholars Program.
- Discussed collaborative efforts with Federally Qualified Health Centers (FQHCs) to enhance screening and identification of rural Veterans. Emphasized use of measurement-based care to track patient progress, outcomes, and identify gaps in care in rural areas.

Dr. Marylene Cloitre, Associate Director, VA Health Care Services – Palo Alto, California

- Discussed purpose, goals, functions, and outcomes of collaborative effort with ORH on web-based treatment program for women Veterans who experienced Military Sexual Trauma (MST) and have subsequent PTSD and depression symptoms.
