

With Power BI, you can pull data from apps and other data sources to create stunning, real-time dashboards that provide deep insights into your data. With simple out-of-the-box dashboards for services like Salesforce, Google Analytics, and Dynamics, you can visualize and make sense of data right away.

Power BI helps users make data-driven decisions no matter where they are. Users can quickly discover patterns as they explore a single unified view of linked, interactive visualizations so your organization can rapidly solve problems as they occur and seize opportunities as soon as they arise.

G5 users can also leverage Microsoft's Phone System to place and receive calls across a wide range of devices and place domestic or international calls from existing phone numbers.


