Office of Substitute Processing

Substitute Paraprofessional (Teacher Assistant) Onboarding

The Substitute Paraprofessional Application Processing office processes principal nominations for potential substitute paraprofessionals. The Office conducts assessment and orientation events to ensure the eligibility of candidates. Eligible Nominees are required to hold a High School diploma or equivalent, complete Child Abuse/ School Violence Prevention/ DASA workshops, in addition to, an online training. Qualified candidates will be staffed in this position and offered employment opportunities within the NYC public school system.

Substitute Teacher Onboarding

The Substitute Teacher Application Processing Office processes principal nominations for potential substitute teachers. The Office conducts orientation events to ensure eligibility of candidates. Eligible Nominees are required to hold a bachelor's degree, complete Child Abuse/ School Violence Prevention/ DASA workshops, in addition to, an online training. Qualified candidates will be staffed in this position and offered employment opportunities within the NYC Public School system.

SubCentral

SubCentral (SubC) is NYC Public Schools' absence management system used by schools to manage the absences of their full-time Teachers and Paraprofessionals. The primary benefit of the system is that it enables full-time Employees to enter an absence directly into the system, even after school hours, using a landline phone or the web, and follow up by contacting a substitute from the approved pool of over 24,000 to fill the absence before the school opens in the morning. The NYCPS covers between 13,000 to 16,000 absences with substitutes daily.

Substitute Renewal

This Office handles the Substitute Teacher and Substitute Paraprofessional Renewal Process, which includes Substitute Reasonable Assurance and Renewal Requirements. All Substitute Teachers and Substitute Paraprofessionals must pass the Renewal Process each summer in order to be eligible for the following school year.

Sub to FT Para Hiring

This Office handles the review of new hire applications for Substitute Paraprofessionals seeking Full Time Paraprofessional Employment. All Paraprofessionals must possess a Teacher Assistant L1 certification in order to be hired. All Paraprofessionals hired after January 31, 2004 are required to obtain a 1) NYS Level II TA Certificate within 3 years of employment, and 2) NYS Level III TA Certificate within 6 years of employment. Paraprofessionals who do not meet these requirements risk termination at the end of the school year.

The Graduate Scholarship Program was created to address the Jose P. Mandates to provide service to students. Bilingual Pupil Services

The Bilingual Pupil Services Program Office is a central-based office providing oversight for this Title I/Tax Levy Program. This Program is managed by the Division of Human Resources and serves Multilingual Learners/English Language Learners (MLLs/ELLs) in Grades K-8. The program hires approximately 45 Bilingual Paraprofessionals annually, who work in non-mandated Dual Language classrooms, Transitional Bilingual classrooms and English as a New Language classrooms providing linguistic and academic enrichment in bilingual reading, mathematics and core content areas to Title I

eligible Multilingual Learners/English Language Learners whose first language is Spanish, Chinese or Haitian Creole.

For pedagogical positions that require NYSED certification, a NYCPS license is issued based on the employee's NYSED certificate and their assignment area. If their NYSED certificate expires, then their NYCPS license becomes invalid.

School Secretary Licensing & Maximum Requirements

School secretaries provide clerical and administrative support to schools and school-based administrators, process timekeeping transactions, and assist staff at schools with forms and HR-related inquiries. School secretaries are selected by school principals and HR directors, and their responsibilities and assignments may vary depending on the school's needs.

Note: Some school secretaries may be referred to by other names such as payroll secretary, leaves secretary, attendance secretary, Pupil Personnel Services secretary, etc.

OSPRA 104

The OSPRA 104 Form is to be filed by individuals who have been previously fingerprinted (after July 1, 1990) for a license and/or employment by the New York City Public Schools (NYC Public Schools) and are authorizing the NYC Public Schools to forward their criminal history to the New York State Education Department for certification application and/or employment purposes.
