

The Delaware Clean Vehicle Rebate Program provides rebates for the purchase or lease of new battery electric and plug-in hybrid electric vehicles as well as dedicated propane and dedicated compressed natural gas vehicles (<u>full program guidelines</u>). To be eligible for a rebate under Funding Round Four, the vehicle must be new and purchased or leased between January 1, 2020 and June 30, 2021 and have a purchase price of \$60,000 or less.

*The Delaware Division of Climate, Coastal, and Energy reserves the right to suspend or extend the program at any time based on availability of funding.

Applicant Eligibility

The following individuals and entities are eligible for rebates under the Delaware Clean Vehicle Rebate Program:

- Businesses, non-profit organizations, or other organizations with both a physical locations and address in Delaware and a Delaware business license;
- State agencies or departments, schools, municipal or county governments in the State of Delaware or;
- Active duty military members stationed in Delaware with a temporary Delaware residential address but with permanent residency in another state.

Purchased Electric Vehicle Eligibility

The following criteria must be met in order for an electric vehicle to qualify for a rebate (<u>list of eligible vehicles</u>):

- Battery Electric Vehicles Vehicles that are powered by high-capacity batteries that are charged using an external power source. Battery Electric Vehicles do not have a gasoline or diesel internal combustion engine (e.g. the Chevrolet Bolt).
- Plug-in Hybrid Electric Vehicles (PHEV) Vehicles that use batteries that are charged by an external power source in conjunction with a gasoline or diesel internal combustion engine (e.g. the Toyota Prius Prime).

Purchase Price cannot exceed \$60,000. The purchase price will be listed on your bill of sale as "Total Cash Price", "Cash Price of Vehicle" or on the lease agreements as "Agreed Upon Value" or similar. The purchase price does not include sales tax.

I understand that only vehicles purchased between January 1, 2020 and June 30, 2021 are eligible for this round of funding under the Clean Vehicle Rebate Program. I understand that incomplete applications will not be processed and submitting an incomplete application may result in loss of rebate due to limited funding availability. I understand and accept that rebate processing will take at least 8-10 weeks from the date the Division of Climate, Coastal, & Energy receives a **complete** rebate application.
