Online applications are now available! LADWP now offers rebates up to \$1,500 through the Used EV Rebate Program for qualifying used electric vehicles (EVs) purchased within 12 months of application submittal. Customers participating in Lifeline or EZ-SAVE Low Income Customer Assistance Program are eligible for an additional \$1,000 rebate.

HOW TO APPLY

You do not need to be an LADWP account holder to apply for the rebate, but your permanent residence must receive electric service from LADWP. If you are an LADWP account holder, you can apply online at ladwp.com/usedEVrebate. You will need to register first with LADWP's My Account if you haven't already.

LADWP will only issue up to two Used EV Rebates for the same EV. Please obtain the VIN of the vehicle you are considering and review the Rebate Issued List found at ladwp.com/usedEVrebate

- 1. Make sure that LADWP issued fewer than two rebates for this vehicle.
- 2. If a rebate was issued to a previous owner, you may only apply for a rebate after twenty-four months following the issue date of the first rebate by LADWP.
- 3. Members of the same household as the applicant who received the first rebate are not eligible to receive a second rebate for the same EV.

Eligibility criteria:

- The vehicle purchased must be included on the approved vehicle list.
- The model year must be at least two years older than the calendar year in which you apply for a rebate, but not older than eight years.
 - For example, if you apply for a rebate in 2022, your vehicle model year must be from 2014 to 2020.
- The rebate application must be submitted within 12 months following the purchase date of the vehicle.

LIFELINE/EZ-SAVE LOW INCOME CUSTOMER ASSISTANCE PROGRAM REBATE ADDER

TERMS AND CONDITIONS

- 1. The LADWP Used Electric Vehicle Rebate Program (the "Program") provides rebates applicable against the cost of purchasing a qualifying used electric vehicle (EV), as defined in Section 5 below (Qualifying EV). The Program may be modified and terminated without prior notice. Applications are accepted on a first-come, first-served basis and are processed in the order received. Funds are limited and rebates are not guaranteed; LADWP may waitlist applications if funding is anticipated to become insufficient. LADWP may also suspend Program enrollment and stop accepting applications until additional funding is authorized. Applications received while Program enrollment is suspended will be deemed received on the first day designated by LADWP for accepting applications to the Program again, provided that LADWP may not accept applications submitted more than 30 days before such designated date. In addition, if, on any given day, LADWP receives multiple applications and funding may become insufficient to cover all such applications, LADWP may conduct a random selection by lottery to determine which applications may be processed, waitlisted, or rejected. Rebate amounts are subject to change at any time and may be greater or less than the value shown in the application.
- Eligible applicants are limited to LADWP residential customers and their household members (including their family members, tenants and residents) and other tenants and residents living permanently at a residential property with an active electric meter served by LADWP. Eligible applicants may only receive a single rebate under the Program regardless of the number of Qualifying EVs purchased.
- 2.1 Subject to all terms and conditions of the Program, customers may be eligible for enhanced rebate amounts, as shown in the Program application. LADWP will verify eligibility (service address's active participation on an eligible program from the date of EV purchase until the issuance of the rebate check). The applicant may be required to demonstrate one of the following in order to be eligible for the rebate adder:
 - Provide a copy of the utility bill indicating that the applicant is the electric service account holder that is enrolled in Lifeline Program or EZ-SAVE Low Income Customer Assistance Program; or
 - Provide proof of residence in an address where the account holder is enrolled in Lifeline Program or EZ-SAVE Low Income Customer Assistance Program.
- The final rebate will be based on the total cost of the vehicle paid by the applicant, minus any other EV financial incentives or rebates received from third parties. The maximum rebate shall not exceed the total cost of the Qualifying EV.
- 4. Up to two used EV rebates are available per Qualifying EV. However, applicants may only apply to the Program for a vehicle previously rebated by LADWP after a twenty-four-month period following the issue date of the first rebate. Applications received before the expiration of such twenty-four-month period will not be accepted by LADWP. Members of the same household as the applicant who received the first rebate are not eligible to receive a second rebate for the same Qualifying EV.
- 5. The Qualifying EV must be:
 - A used, operational, four-wheel, light-duty, on-road, plug-in electric vehicle (battery electric vehicle or plug-in hybrid

- electric vehicle) registered with the DMV, DOT-approved for highway application, approved by the California Air Resources Board for single occupancy in high-occupancy vehicle lanes, and included in the Program's vehicle eligibility list published by LADWP. LADWP has sole discretion to determine which vehicles are included in the vehicle eligibility list. Golf carts, neighborhood carts, motorcycles, and electric scooters are not Qualifying EVs under this Program; and
- Purchased within 12 months of rebate application submittal.
 Rebate applications received after a year since purchase of qualifying used EV will not be accepted; and
- Registered with the California Department of Motor Vehicles (DMV) in the name of the applicant at the permanent address provided in the Program's application. Leased or rented vehicles (or any other form of possession where the applicant is not identified as the owner by the DMV), vehicles received as family transfers, gifts and prizes do not qualify for a rebate under the program; and
- A model at least two years older, but not older than eight years, than the calendar year in which the applicant applies for a rebate under the Program. For example, if an applicant submits their application in 2022, the Qualifying EV must be a 2014 to 2020 model, as shown on the DMV registration.
- 6. Eligible applicants must submit a completed application along with all required documentation to LADWP within 12 months following the purchase date of the qualifying EV.
- 7. Completed application, along with all required support documentation, must be submitted to LADWP by U.S. mail or, if available, online at LADWP.com. Only paper and online applications will be accepted. Paper applications must have an original signature. Faxed, scanned, or emailed applications WILL NOT be accepted. Applications received by LADWP that are missing the required documentation, or that do not meet Program requirements will be considered ineligible for a rebate. LADWP is not responsible for documents lost or destroyed in the mail via transit or misdirected applications. Submitted rebate applications and accompanying documents become the property of LADWP and will not be returned.
- 8. LADWP reserves the right to inspect the Qualifying EV at any time with reasonable notice. Eligible applicants agree to provide LADWP's representative reasonable access to the Qualifying EV during normal business hours at the address shown in this application and on the DMV registration. Any refusal by eligible applicants to allow reasonable access to the Qualifying EV for the purpose of inspection by an authorized LADWP representative may result in forfeiture of the rebate.
- 9. The City of Los Angeles and LADWP make no warranties and are not responsible for any representations, whether expressed or implied, including, but not limited to, the warranty of merchantability, fitness for a particular use, product performance and useful life, or application of the item(s) or measure(s) manufacturers, dealers, contractors, or any other third parties, materials, workmanship, the quality, safety and/or installation of the item(s) or measure(s), effects on pollutants or any other matter with respect to the Program.
