Reimbursement Updates

Medicaid: The Medicaid Managed Care Fireside Chat Series offered by the North Carolina Department of Health and Human Services and North Carolina Area Health Education Centers (AHEC) kicked off on October 1St. This webinar, which will *reoccur on the third Thursday of each month*, is one of two monthly evening webinar series designed to help prepare providers, practice managers, and quality managers for Medicaid Managed Care going live on July 1, 2021. Telehealth: The resources provided on the Payer Relations page at www.aptanc.org continues to be the best link for updates on policy regarding telehealth coverage. Updates are published frequently by different insurance companies.

Covid 19: The American Medical Association released a new CPT code designed for practices to report expenses incurred during a public health emergency. The following link

Federal Affairs: The proposed Medicare Physician Fee Schedule for 2021 is calling for an estimated 9% decrease in payment for codes tied to Part B physical therapist services. These cuts will do monumental damage and Congress must hear from thousands of PTs and PTA's.
