



## **Terms & Conditions – Family Wish List 2023**

1. The competitions are conducted by Wernhil Park (Pty) Limited (Registration number: 1071) on behalf of Broll & List Property Management (PTY) Ltd (Registration number 2002/0130), the owners and tenants of Wernhil Shopping Centre.
2. This competition is open to Namibian citizens or permanent residence permit holders only.
3. The competition is open only to individuals aged 18 years or older.
4. No person may, on behalf of a third party, enter any competition hosted partly or in whole by Wernhil. All entries must be made personally by the entrant.
5. No O&L Director, Broll Namibia & Wernhil staff member, Wernhil Tenant & tenant staff, Wernhil service agent (Omega Security, LIDA Cleaning Services and Advance Parking Solutions) and service agent staff members directly employed on and off the site, consultant, or anybody directly or indirectly involved in this competition; any spouse, life partner, dependant family member, child and their life partner or spouse is permitted to participate.
