DATA PRIVACY AND PROTECTION

- 2. The LESSOR may collect Personal Information from and disclose Personal Information to other service providers of the LESSOR, including credit bureaux, attorneys and collection agencies (for the collection of outstanding amounts). - 3. The LESSOR may, from time to time, store, transfer and Process Personal Information in and to countries outside of the Republic of South Africa.  - 4.2 utilise reasonable technical and organisational measures in accordance with best industry practice for the purpose of complying with its obligations;
 - 4.3 at all times comply with POPIA and other applicable laws, regulations or codes relating to data protection in the Republic of South Africa, or other requirements enforced by any relevant industry or self-regulatory body within the Republic of South Africa in furtherance of the terms and conditions of this agreement; and
 - 4.4 not, at any time copy, compile, collect, collate, Process, mine, store, transfer, alter, delete, interfere with or in any other manner use the Personal Information for any purpose other than in furtherance of the terms and conditions of this agreement, other than with the express prior written consent of the LESSEE.
- 5. The LESSEE undertake to separate any Personal Information from any other data provided to the LESSOR for purposes of this agreement and shall designate the Personal Information as such before disclosing or otherwise making it available to the LESSOR.
- 6. The LESSEE shall immediately notify the LESSOR if there is any change to its Personal Information.
- 7. The LESSEE is entitled to withdraw its consent to the Processing of its Personal Information by giving written notice to the LESSOR together with the grounds therefor; provided that the lawfulness of the Processing of Personal Information before such withdrawal will not be affected or the withdrawal will not affect any Processing that:
 - 7.1 is necessary to carry out actions for the conclusion or performance of the agreement;
 - 7.2 complies with an obligation imposed by law on the LESSOR;
 - 7.3 protects a legitimate interest of the LESSEE; or
 - 7.4 is necessary for pursuing the legitimate interests of the LESSOR or a third party to whom the Personal Information is supplied.
- 8. The LESSEE is entitled to:
 - 8.1 object, by written notice to the LESSOR, to the Processing of its Personal Information on reasonable grounds, unless legislation provides for such Processing;
 - 8.2 lodge a complaint to the Information Regulator, established or to be established in terms of POPIA, regarding the alleged unlawful processing of the LESSEE's personal information by the LESSOR.
