

MN Homeownership Rates by Race and Ethnicity





Percentage Point Gap in Homeownership Rates	33.4%	4 th Largest




Median Home Sale Price in Minnesota: Increasing Since 2011


Months Supply of Homes for Sale in Minnesota: Well Below 5 Months in Recent Years






Home Mortgages Financed by Minnesota Housing

Share of Mortgages to Black, Indigenous and People of Color Communities




Minnesota Housing's Share of the 2019 Mortgage Market



Manufactured Home Community Redevelopment Program

- Grant funds for infrastructure redevelopment and/or acquisition of manufactured home community
- \$2 million in state appropriations
 - Housing Infrastructure Bond (HIB) proceeds eligible source of funds
- \$5,104,642 in proposals received
- \$2,600,000 awarded in December 2020
