- Primary Key Uniquely specifies a record in that back-office file
- Product Hierarchy A tree structure showing what is common and what varies across content sets
- Universe and Universe Subset The set of financial instruments included in the content set
- Field Layout A reference to the metadata stating which Fields are in the file, and it's structure
- Earliest/Latest Delivery –
 Delivery window for the content in standard iCalendar format
- URI A compact sequence of characters that identify a resource
- File System Location The URL for where the content set is located
