FOR PROFESSIONAL ACHIEVEMENT IN THE PERFORMANCE OF HIS DUTIES WHILE SERVING AS CHIEF PETTY OFFICER IN USS MILIUS FROM 03 FEBRUARY 2018 TO 01 MARCH 2021. CHIEF PETTY OFFICER HECKENLAIBLE PERFORMED HIS DUTIES IN AN EXEMPLARY AND HIGHLY PROFESSIONAL MANNER. DURING MILIUS HOMEPORT SHIFT, FIVE BMD MISSIONS, THREE SEVENTH FLEET PATROLS, AND A UNITED NATIONS SECURITY COUNCIL TASKING HE FLAWLESSLY ESTABLISHED 24 COMMUNICATION PLANS, COORDINATED A SEAMLESS SEVENTH FLEET CUTOVER AND PIONEERED DUEL SHF SERVICES. 
