**Investment Objective:** To achieve long term capital appreciation by investing in a diversified portfolio of stocks that replicate the Standard & Poor's 500 Index.

**Investment Strategy:** The mutual fund manager, **The Vanguard Group, Inc.** employs a "passive management"—or indexing—investment approach. This approach is designed to track the performance of the Standard & Poor's 500 Index, a widely recognized benchmark of U.S. large capitalization companies. The fund uses the replication method of indexing, meaning that it holds the same stocks as its target index and in the same proportions.

**Mutual Fund Company:** The Vanguard Group, Inc. is an investment management company based in Malvern, Pennsylvania. The firm offers mutual funds and other financial products and services to individual and institutional investors in the United States and abroad. Vanguard is unusual among mutual-fund companies since it is owned by the funds themselves. In this structure, each fund contributes a set amount of capital towards shared management, marketing, and distribution services. The company says that this structure better orients management towards shareholder interests.


