Coding for Some Preventive Medicine Service Encounters

Note: Scenarios were created for coding teaching purposes only.

Encounter

A nine-day old presents to the office after a normal delivery and normal transition in the hospital. Baby is established to the practice and is doing well and had gained some weight. A routine preventive medicine service is performed. What CPT and ICD-10-CM codes are reported?

Encounter

A six-day old presents to the office after a normal delivery and normal transition in the hospital. Baby is established to the practice. Upon exam the physician noted some jaundice features. He spoke to the mom about feeding and urine output. He performs the routinely recommended service at 3-5 days post discharge and also completes an acute visit for the jaundice, including writing orders for a blood draw and subsequent home care for a biliblanket after the results revealed an elevated bili level. The diagnoses listed are routine baby exam and jaundice. What CPT and ICD-10-CM codes are reported?

Teaching Point: The codes for routine newborn encounters do not designate between with and without abnormal findings. However, they are still reported based on the patient's age.

Encounter

A 2-month old new patient presents for her routine well baby exam. Mom had no complaints, however upon exam an innocent heart murmur was noticed. No heart problems are noted in the family history. The pediatrician informed the mom about it and told her that nothing needed to be done at this point, but would follow-up at the baby's next encounter. Vaccines are ordered (DTaP-Haemophilus influenzae type b (Hib)-inactivated poliovirus (IPV) (Pentacel), Hepatitis B, pneumococcal, and rotavirus) and the mom is counseled on them all. The diagnosis listed is well baby exam, vaccine encounter and innocent heart murmur. What CPT and ICD-10-CM codes are reported?

Teaching Point: Because the heart murmur finding did not lead to a significant and separately identifiable E/M service, only the preventive medicine service is reported. Also, Z23 is the only ICD-10-CM code for vaccines.

<u>Encounter</u>

A 4 year old presents for her yearly check-up and a preschool physical. As recommended by the periodicity schedule, a vision and hearing screen are ordered and performed. Both are within normal range. Patient receives an MMRV and IPV. Diagnosis is well child exam and preschool physical.

Teaching point: Because the vision and hearing screen are part of the routine well child exam ICD-10-CM guidelines state "A screening code is not necessary if the screening is inherent to a routine examination, such as a pap smear done during a routine pelvic examination." Therefore you only need the Z00.129 to link to the screening. Z01 codes are not appropriate in these circumstances because category Z01 codes are first listed codes and in this case the primary reason for the encounter is a routine well child exam (Z00.12-). If the payer requires a screening code, you could use Z13.5 (encounter for screening for eye and ear disorders), however that should not be required.

Encounter

An 18-year-old presents for their annual exam and vaccines before they leave for college. Patient has been healthy and claims to not be sexually active. Had an STI/HIV screen test last year so no need for repeat. A depression screen is performed, which is normal. Vaccines are given.

MODIFIER 33

While not specified in the scenarios above, modifier **33** may be appended to any CPT this should not be allocated to patient or family cost-sharing as part of the Affordable Care Act. While not all payers require this modifier, some do. You will report modifier **33** on any CPT code reported for a service (this is not inherently preventive already like the preventive medicine service code) that falls under Bright Futures recommendations; the United States Preventive Services Task Force A or B recommendations; and ACIP recommended vaccines. This modifier tells the payers that no cost-sharing should occur.
