### What does the fund invest in?

The fund invests primarily in securities that are included in the NASDAQ-100 Index, which represents the NASDAQ's 100 largest non-financial companies across major industry groups including computer hardware and software, telecommunications, retail/wholesale trade, and biotechnology. The fund may also invest in derivatives in order to track the index.

The charts below give you a snapshot of the fund's investments on April 30, 2023. The fund's investments will change.

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### Risk rating

CIBC has rated the volatility of this fund as **Medium to High**.

This rating is based on how much the fund's returns have changed from year to year. It does not tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

#### No guarantees

Like most mutual funds, this fund does not have any guarantees. You may not get back the amount of money you invest.

### How has the fund performed?

This section tells you how Class F units of the fund have performed over the past 2 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

**YEAR-BY-YEAR RETURNS**

This chart shows how Class F units of the fund performed in each of the past 2 calendar years. Class F units dropped in value in 1 of the 2 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.

**BEST AND WORST 3-MONTH RETURNS**

This table shows the best and worst returns for Class F units of the fund in a 3-month period over the past 2 calendar years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

**AVERAGE RETURN**

The annual compounded return of Class F units of the fund since July 6, 2020 was 7.9%. If you had invested \$1,000 in the fund on July 6, 2020, your investment would be worth \$1,239 as at April 30, 2023.

**Who is this fund for?****Investors who:**

- are seeking diversification with specific exposure to the U.S. technology sector and returns similar to those of the NASDAQ-100 Index; and
- are investing for the long term.

**A word about tax**

In general, you will have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan (RRSP) or a Tax-Free Savings Account (TFSA).

Keep in mind that if you hold your fund in a non-registered plan, fund distributions are included in your taxable income, whether you receive them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own, and sell Class F units of the fund. The fees and expenses - including any commissions - can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

We automatically convert eligible investors from Class F units into the Class F-Premium units of the fund (bearing a lower management fee) when their investment amount in Class F units of the fund, or their aggregated investment amount in Class F units and Class F-Premium units of the fund, within a single account meets the minimum investment amount of Class F-Premium units of \$50,000. Eligible investors will benefit from a management fee decrease. See *Automatic conversion program* below under the sub-heading *Fund Expenses*. If you no longer meet the minimum investment amount for Class F-Premium units, we may convert your Class F-Premium units back into Class F units which have a higher management fee. See *Purchases, Switches and Redemptions* in the fund's simplified prospectus and speak to your investment advisor for additional details.

**1. SALES CHARGES**

There are no sales charges payable when you buy, switch, or sell Class F units of the fund.

**2. FUND EXPENSES**

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As at December 31, 2022, the expenses for Class F units of the fund were 0.99% of its value. This equals \$9.90 for every \$1,000 invested.

<b>Management expense ratio (MER)</b> This is the total of the fund's management fee (including the trailing commission), fixed administration fee, and any operating expenses not covered by the fixed administration fee (fund costs) for Class F units of the fund. CIBC waived or absorbed some of the fund's expenses. If it had not done so, the MER would have been higher.	0.99%

**Automatic conversion program**

The management fee decrease from Class F units to Class F-Premium units is 0.35%.

**More about the trailing commission**

No trailing commission is paid in respect of Class F units.

**3. OTHER FEES**

You may have to pay other fees when you buy, hold, sell, switch, or convert units of the fund.

Fee	What you pay
<b>Fee-based arrangements</b>	You can only buy Class F units through representative firms who have entered into a Class F agreement with CIBC. Class F units are available, subject to certain minimum investment requirements, to investors participating in certain programs, such as clients of "fee-for-service" investment advisors, dealer-sponsored "wrap accounts", and others who pay an annual fee to their dealer, and to investors who have accounts with a discount broker (provided the discount broker offers Class F units on its platform). Instead of paying a sales charge, investors purchasing Class F units may pay fees to their dealer for their services.
<b>Short-term trading fee</b>	Up to 2% of the value of units you sell or switch within 30 days of buying them. This fee goes to the fund.
<b>Switch fee</b>	If you sell units of the fund to buy units of another fund, you may pay a switch fee of up to 2% of the value of units you switch. This fee goes to your representative's firm.
<b>Conversion fee</b>	If you convert units of the fund to another class of units of the same fund, you may pay a conversion fee of up to 2% of the value of units you convert. This fee goes to your representative's firm.

**What if I change my mind?**

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document, or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
