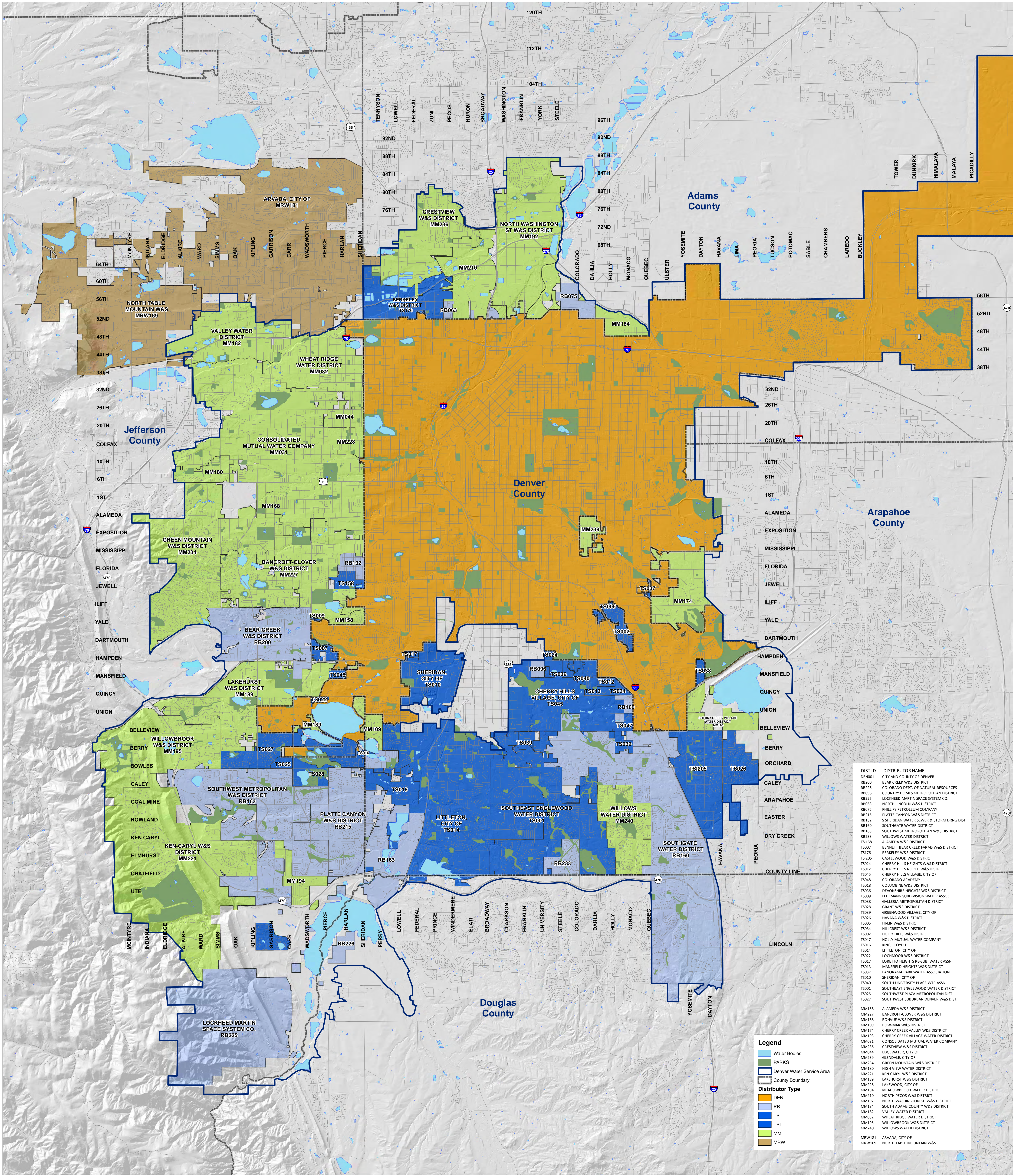

DENVER WATER DISTRIBUTOR CONTRACT BOUNDARIES



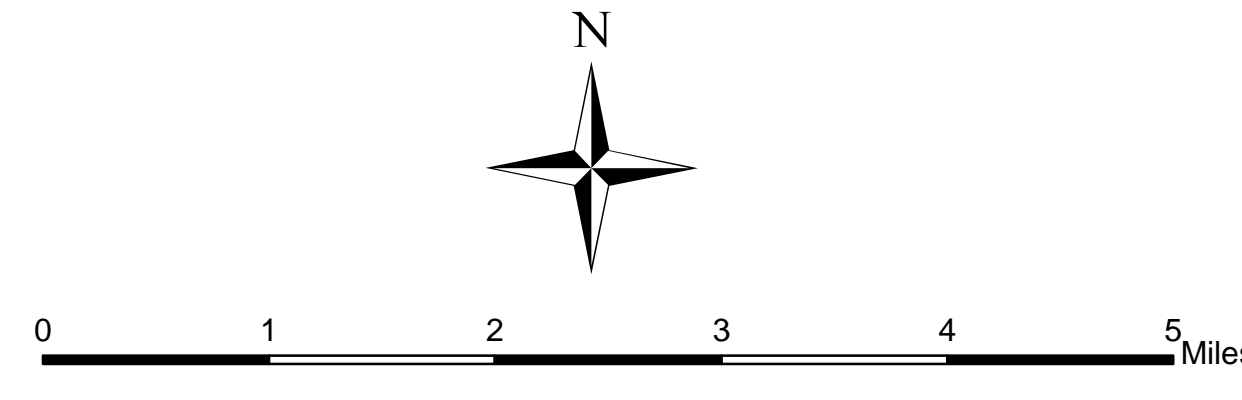
