The Annual Wellness Visit:

What it is...

- ✓ Personalized Prevention Plan
- Provider-Patient Communication
- ✓ Home Safety
- ✓ Health Risks
- ✓ Advance Care Planning

What it is not...

- X Physical Exam
- × Opportunity
- X Routine Labs
- X Co-insurance/Codeductible





Who are the Beneficiaries & Scheduling the Visit

- Identify the population
- Medicare Part B covered
 - 12 months
 - G0438 initial
- No initial Preventive Physical Examination
 - 12 months







Who are the Beneficiaries & Scheduling the Visit

- Subsequent AWVs post initial AWV
 - 12 months
 - G0439 subsequent years
- Post initial AWV
 - Schedule subsequent AWV
 - Query of last 6 months of billing codes





What are the Costs?

- Provider accepts assignment of Medicare Part B
 - Patient pays nothing
 - Coinsurance
 - Part B deductible may apply
 - Additional tests
 - » Clinical laboratory tests
 - Additional services
 - » Referrals
 - During the visit
 - Required diagnosis code
 - Current procedural terminology (CPT) code w/ modifier -25





AWV Components & Workflows

- Health Risk Assessments
 - Personalized prevention plan
 - Demographic data
 - Health status
 - Injury risks
 - Behavioral Risks
 - Urgent health needs
- Medical & Family History
- ▶ List of current providers & RX's
 - Durable medical equipment (DME)







AWV Components & Workflows

- Height, weight, blood pressure, & other routine measurements
- Cognitive impairment detection
- ▶ Health advice

- Risk factors & treatment options
 - Functional ability & level of safety
- Depression screening
 - PHQ-2/9 or Screening,
 Brief Intervention, and
 Referral to Treatment
 (SBIRT)
- Screening for Chronic Care Management





AWV Components & Workflows

Screening Schedule

Colon CA

Breast CA

Cervical CA

Influenza
Immunization

Pneumococcal
Vaccine

Advance Care Planning

- Advance Care Planning
 - Face-to-face discussion with or without completion of relevant legal forms
 - Beneficiary appoints agent/records wishes for medical treatment
- Patient eligibility
 - Optional element for AWV
- Advance Care Planning
 - Provider and location eligibility
 - Diagnosis







Advance Care Planning

Coding

Table 1. CPT Codes and Descriptors

CPT Codes	Billing Code Descriptors
99497	Advance care planning including the explanation and discussion of advance directives such as standard forms (with completion of such forms, when performed), by the physician or other qualified health care professional; first 30 minutes, face-to-face with the patient, family member(s), and/or surrogate
99498	Advance care planning including the explanation and discussion of advance directives such as standard forms (with completion of such forms, when performed), by the physician or other qualified health care professional; each additional 30 minutes (List separately in addition to code for primary procedure)



Advance Care Planning



Billing

- Provided on the same day as a covered AWV
- Furnished by the same provider as a covered
 AWV
- Billed with modifier -33 (Preventive Services)





Subsequent AWVs

- Check weight and blood pressure
- Update the previous completed health risk assessment
- Update medical and family history
- Update the list of current medical providers and

suppliers





Subsequent AWVs

- Update the written screening schedule
- Cognitive issues screening
- Provide health advice
- Provide referrals to health education and/or preventive counseling services
