### Mr. Bronczek Net Worth

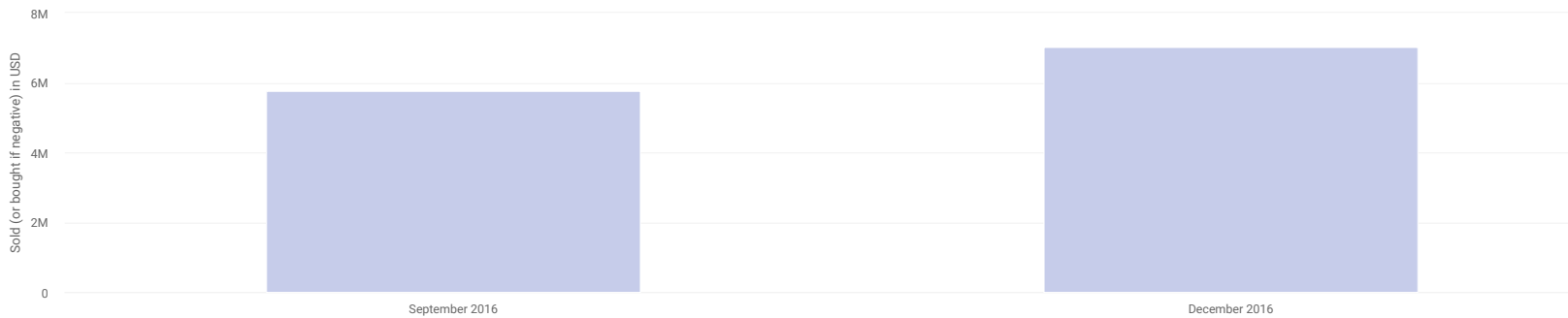
The estimated Net Worth of David J Bronczek is at least \$35.9 Million dollars as of 2 January 2018. Mr. Bronczek owns over 47,656 units of FedEx stock worth over \$16,311,689 and over the last 2 years he sold FDX stock worth over \$12,776,035. In addition, he makes \$6,800,450 as President and Chief Operating Officer at FedEx.

The largest trade he's ever made was exercising 47,656 units of FedEx stock on 2 January 2018 worth over \$2,721,634. On average, David trades about 11,685 units every 46 days since 2016. As of 2 January 2018 he still owns at least 94,566 units of FedEx stock.

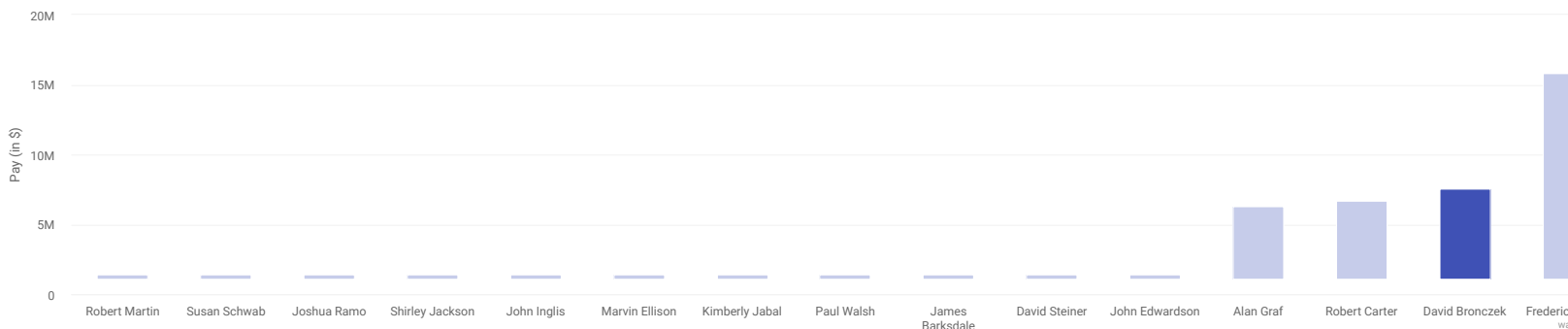
### David Bronczek biography

David J. Bronczek is a **President, Chief Operating Officer** of the Company effective February 01, 2017. He was President and Chief Executive Officer of FedEx Express from January 2000 to February 2017; Executive Vice President and Chief Operating Officer of FedEx Express from January 1998 to January 2000; Senior Vice President – Europe, Middle East and Africa of FedEx Express from June 1995 to January 1998; Senior Vice President – Europe, Africa and Mediterranean of FedEx Express from June 1993 to June 1995; Vice President – Canadian Operations of FedEx Express from February 1987 to March 1993; and various management positions in sales and operations at FedEx Express from 1976 to 1987. Mr. Bronczek serves as a director of International Paper Company, an uncoated paper and packaging company.



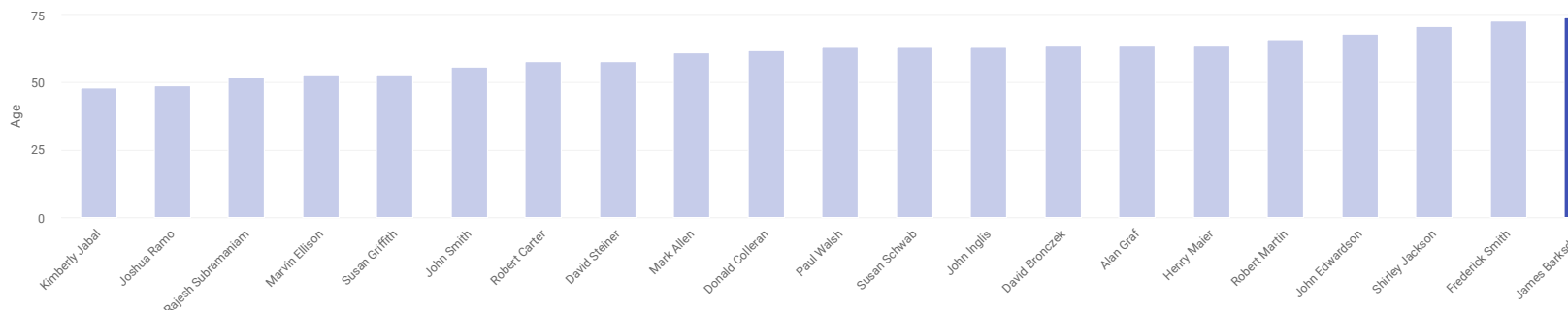
## What is the salary of David Bronczek?

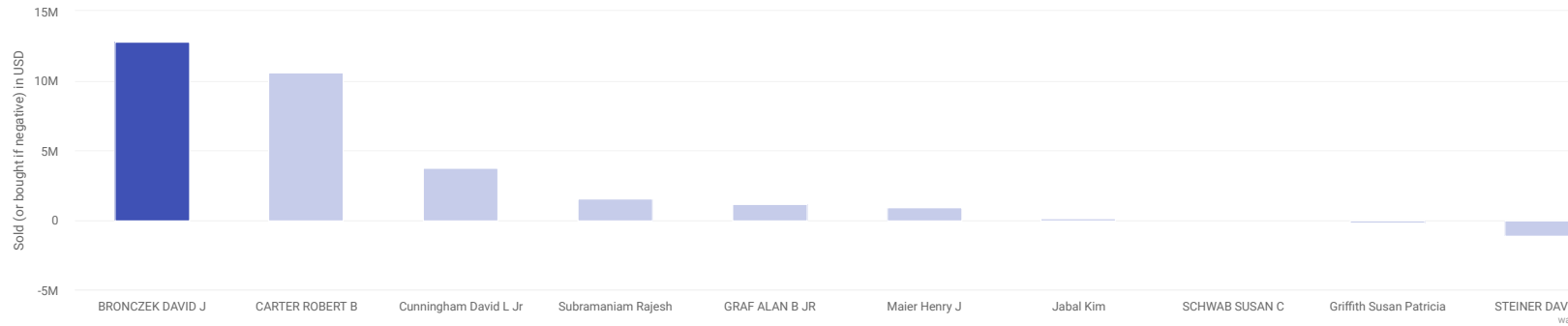

## Insider trading at FedEx

Over the last 3 years, [insiders at FedEx](#) have traded over \$30,810,308 worth of FedEx stock and bought 8,080 units worth \$1,385,437. The most active insider traders include [David P Steiner](#), [Frederick W Smith](#), and [R Brad Martin](#). On average, FedEx executives and independent directors trade stock every 17 days with the average trade being worth of



\$3,217,283. The most recent stock trade was executed by **David P Steiner** on 2 January 2019, trading 7,000 units of FDX stock currently worth \$1,140,440.




## What does FedEx do?

FedEx Corporation provides transportation, e-commerce, and business services worldwide. The company's FedEx Express segment offers shipping services for delivery of packages and freight. Its FedEx Ground segment provides business and residential money-back guaranteed ground package delivery services; and consolidates and delivers low-weight and less time-sensitive business-to-consumer packages. The company's FedEx Freight segment offers less-than-truckload and freight delivery services. As of May 31, 2018, it operated approximately 27,000 vehicles and 370 service centers. The company's FedEx Services segment provides sales, marketing, information technology, communications, customer, technical support, billing and collection, and other back-office support services. It also offers FedEx Mobile, a suite of solutions to track packages, create shipping labels, view account-specific rate quotes, and access drop-off location information; FedEx Office, a suite of printing and shipping management solutions for copying and digital printing, professional finishing, document creation, direct mail, signs and graphics, computer rentals, Wi-Fi, and corporate print solutions; and packing services, supplies, and boxes, as well as FedEx Express and FedEx Ground shipping services. The company's Corporate, Other and Eliminations segment offers international trade services in customs brokerage, and ocean and air freight forwarding services; cross-border enablement and technology solutions, and e-commerce transportation solutions; integrated supply chain management solutions; time-critical shipment services; critical inventory and service parts logistics, 3-D printing, and technology repair. This segment also provides international trade advisory services, including assistance with the customs-trade partnership against terrorism program; and publishes customs duty and tax information. FedEx Corporation was founded in 1971 and is headquartered in Memphis, Tennessee.
