PROBAR LLC of Salt Lake City, UT has initiated a voluntary recall of select flavors and lots of Meal[®] bars, including Chocolate Coconut, Peanut Butter Chocolate Chip, Original Trail Mix, Wholeberry Blast and Superfood Slam due to the possible presence of undeclared milk and soy allergens. People who have an

allergy or severe sensitivity to milk or soy may run the risk of a serious or life threatening allergic reaction if they consume the affected products. No other PROBAR® products are affected.

Company Announcement

Flowers Foods, Inc. (NYSE: FLO) is voluntarily recalling hamburger and hot dog buns and other bakery products due to the potential presence of small pieces of hard plastic that may have been introduced during production. Consumption of product may cause a choking hazard.

The products being recalled were distributed to retail customers under a variety of brand names and distributed in Alabama, Arkansas, Florida, Georgia, Illinois, Indiana, Kansas, Kentucky, Louisiana, Missouri, Mississippi, North Carolina, Ohio, South Carolina, Tennessee, Texas, Virginia, and West Virginia.

The company initiated the recall following the discovery of small pieces of hard plastic in production equipment. No related injuries or illnesses have been reported. Company Announcement

With the [recent announcements of the Food and Drug Administration \(FDA\) and the Centers for Disease Control and Prevention \(CDC\)](#) investigating contaminated Pig Ear Treats connecting to *Salmonella*, Pet Supplies Plus is advising consumers it is recalling bulk pig ear product supplied to all locations by several different vendors due to the potential of *Salmonella* contamination. *Salmonella* can affect animals eating the products and there is risk to humans from handling contaminated pet products, especially if they have not thoroughly washed their hands after having contact with the products or any surfaces exposed to these products.

Individuals infected with *Salmonella* should monitor for some, or all, of the following symptoms: nausea, vomiting, diarrhea or bloody diarrhea, abdominal cramping and fever. Rarely, *Salmonella* can result in more serious ailments, including arterial infections, endocarditis, arthritis, muscle pain, eye irritation, and urinary tract symptoms. Consumers exhibiting these signs after having contact with this product should contact their healthcare providers.

Pets with *Salmonella* infections may be lethargic and have diarrhea or bloody diarrhea, fever, and vomiting. Some pets will have only decreased appetite, fever and abdominal pain. Infected but otherwise healthy pets can be carriers and infect other animals or humans. If your pet has consumed the recalled product and has these symptoms, please contact your veterinarian.

Bulk pig ears were distributed to Pet Supplies Plus stores in AL, AR, CA, CO, CT, DE, FL, GA, IA, IL, IN, KS, KY, MA, MD, MI, MN, MO, NC, NE, NH, NJ, NY, OH, OK, PA, RI, SC, TN, TX, VA, WI and WV. Bulk pig ears were stocked in open bins. Prepackaged branded pig ears are not included in this voluntary recall.

To date, 45 individuals in 13 states have been diagnosed with *Salmonella* related illness. However, none of these cases are confirmed to be a result of purchasing pig ears from Pet Supplies Plus.

Testing by the Michigan Department of Agriculture and Rural Development revealed that aging bulk pig ear product in one of our stores tested positive for *Salmonella*. We have pulled bulk pig ear product from the shelves at all of our stores and have stopped shipping

bulk pig ears from our Distribution Center. We are working with the FDA as they continue their investigation as to what caused the reported *Salmonella* related illnesses.

Consumers who have purchased bulk pig ears should discontinue use of the product and discard it. Consumers who have further questions are welcome to contact our Neighbor Service team at 734-793- 6564 between Monday and Friday 9 a.m. - 4 p.m. EST (excluding holidays).

Company Announcement

Growers Express takes issues of food safety seriously and is issuing a voluntary recall of select fresh vegetable products in an abundance of caution and in the interest of protecting its customers and end consumers. The fresh vegetable products include packaged varieties of butternut squash, cauliflower, zucchini and a butternut squashed based veggie bowl. Please refer to the detailed chart below for specific product names and retailers.

The products originate from a Growers Express production facility in Biddeford, Maine and were distributed to the states referenced in the chart below. The voluntary recall was issued due to the potential for contamination with *Listeria monocytogenes*. There are no reported illnesses.

Listeria is an organism that can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Although healthy individuals may suffer short-term symptoms such as high fever, severe headaches, stiffness, nausea, abdominal pain and diarrhea. *Listeria* infection can cause miscarriages and stillbirths among pregnant women.

Most of the affected products are labeled with a "Best If Used By" Date of June 26 – June 29, 2019. No other Growers Express products are impacted or part of this recall. This recall does not affect or include any Green Giant® canned or frozen vegetable products.

"The safety of our consumers is our first priority," said Tom Byrne, President of Growers Express. "We self-reported the need for this recall to the U.S. Food and Drug Administration (FDA) and stopped production immediately after being notified of a single positive sample by the Massachusetts Department of Health. We are deep sanitizing the entire facility and our line equipment, as well as conducting continued testing on top of our usual battery of sanitation and quality and safety tests before resuming production."

Consumers who purchased any of the products listed below from the affected sell by dates or with an unreadable date code are urged not to consume them and to throw the products away.
