

FEFP Legislative Changes

- o Pursuant to HB 7069, the following allocations are to be recalculated after each FTE student enrollment survey:
 - ESE Guaranteed Allocation
 - Supplemental Academic Instruction Allocation
- The Federally Connected Student Supplement will be recalculated in the fourth FEFP calculation.
- o Eliminates the cap on the total bonus a teacher can earn from IB, AICE, AP and CAPE bonus programs.
- Districts are no longer required to submit a Digital Classrooms Plan.



FTE (Full Time Equivalent Student)

180 day term or hourly equivalent required by Section 1011.60(2),F.S. The hourly requirements are specified in Rule 6A-1.045111, FAC.

- 720 Hours of Instructional Time for Prekindergarten through Grade 3 Students (180 days x 4 hours per day)
- 900 Hours of Instructional Time for Grades 4 through
 12 Students (180 days x 5 hours per day)

FTE Alternate Survey

Alternate Survey

Authority: Rule 6A-1.0451, FAC.



Prior to the standard survey week, a district may request an alternate FTE survey week (within 9 weeks of the original survey) if membership is expected to fluctuate due to reasons beyond the district's control such as natural disasters, agricultural migration, civil disturbances etc..

To be considered a district must expect a potential membership change of greater than 5% for the entire district or 25% for a specific school.

If approved the district must still conduct the regular survey. Prior to submitting the alternate survey the district will verify with DOE staff that they will meet the above thresholds. The thresholds will be verified after the data is submitted.



Proration to the Appropriation

Proration to the Appropriation

If the funds appropriated for current operation of the FEFP are not sufficient to pay the state requirement in full, the department shall prorate the available state funds to each district.

Authority: s. 1011.62(14), F.S.

Each district's reduction to state funding is based on the district's share of total gross state and local funding.



The Proration to the Appropriation can only be a reduction in funds.

Group 2 WFTE Capping

Group 2 WFTE Capping

Authority: s. 1011.62(1)(d)3.c, F.S.



Group 2 WFTE includes FTE in Programs 130, 254, 255 and 300.

A district is exceeding the cap when the total WFTE in these programs is greater the total group 2 Weighted FTE in the conference report.

The total WFTE over the cap is distributed based on each programs share of WFTE over that cap.

Once the WFTE over cap is identified by program the weighted value is removed from the FTE so that these over cap FTE receive a funding weight of 1.0.



Florida Price Level Index and DCD

District Cost Differential

Authority: s. 1011.62(d), F.S. Florida Polytechnics University creates the Florida Price Level Index (FPLI) on an annual basis.

Extensive data on wages is used to estimate the relative cost of hiring comparable workers among Florida's 67 counties in a given year. The index is constructed so that the population weighted average is 100.

A 3 year average of this index is multiplied by 80% and then 20 is added before dividing by 100. The affect is that the DCD is based on 80% of the 3 year average.



Teacher Bonuses: CAPE

 The following bonuses are required from the funds in the 2017-18 FEFP Calculation:

Funding Weight on the 16-17 ICFL	Required Teacher Bonus in 2016-17
0.1 Weight	\$25
0.2 Weight	\$50
0.3 Weight	\$75
0.5 Weight	\$100
1.0 Weight	\$100

In addition the maximum teacher bonuses were removed from statute.



School Transportation Funding

School Transportation

Authority: s. 1011.68, F.S.



Eligibility

- 1. 2 miles or More from school
- 2. ESE Student whose IEP requires transportation
- 3. Teen Parent
- 4. Hazardous Walking (K-6 elementary only)

Base Riders: All riders that meet the eligibility requirements listed above. Includes weighted riders.

Weighted riders: all ESE riders that require special transportation services on their IEP (example: Aides, wheelchair lift),



School Transportation Funding

School Transportation

> Authority: s. 1011.68, F.S.



Adjusted Base/Weighted Riders: Riders that have been adjusted by the term length they were served out of 180 days (most students served 90 days per semester and would receive 0.5 in survey 2 and 0.5 in survey 3).

Other Adjustments / Allocation Factors:

- 1. Average Bus Occupancy Index (ABO)
- 2. Rurality Index
- 3. Florida Price Level Index (FPLI)
- 4. 1.8 factor applied to weighted ESE students

ESE Transportation Allocation: weighted allocation factor multiplied by legislative ESE allocation.

Base Transportation Allocation: Remaining Allocation based on base allocation factor

School Recognition



Schools may qualify for school recognition in the following ways:

Schools that sustain high performance by receiving a school grade of "A;" or

Schools that demonstrate exemplary improvement due to innovation and effort by improving at least one letter grade; or


Schools that improve more than one letter grade and sustain the improvement the following school year



Federally Connected Student Supplement

Authority: s. 1011.62(13), F.S.



\$12,883,871 has been allocated for the Federally Connected Student Supplement.

For students connected with federally owned military installations, National Aeronautics and Space Administration (NASA) property, and Indian lands.

Must be eligible for federal Impact Aid Program funds under s. 7003 of Title VII of the Elementary and Secondary Education Act of 1965.

Exempt Property Allocation: Capital Outlay Millage rate applied to value of exempt property.

Student Allocation: All qualifying students receive 3% of the BSA (\$126). Qualifying students with disabilities receive an additional 10.5% of the BSA (\$441).



Class Size Compliance

Class Size Compliance

- Measured at the:
 - Individual classroom level for Traditional Public Schools
 - School wide average for Charter Schools and District-Operated Schools of Choice.
- Measures only core courses.
- Excludes virtual and blended learning courses.
- Class size funding adjustments are made for each student causing each classroom to exceed the class size maximums.
- Funding adjustments for charter schools, district-operated schools of choice and traditional public schools are made independent of each other.
- Section 1003.03(3), F.S., provides acceptable methods for meeting class size requirements.

McKay Scholarship Funding

McKay Scholarship Funding

Authority: s. 1002.39(10), F.S.



McKay Scholarships are provided to students with disabilities to go towards private school tuition.

McKay Scholarships are funded from the same fund source as the FEFP. Districts report McKay FTE and generate funding based on the FTE they report.

Funds are then reduced from the district's FEFP allocation to pay the actual scholarships.
