In order to assist migrants applying to resettle in the United States, for a fee, IOM Vietnam provides professional, transparent application assistance as per the most up-to-date U.S. guidelines.

1- Immediate Relatives of U.S. Citizens

- spouse (IR1 or CR1)

- unmarried children under age 21 (IR2)
- parents (IR5) of a U.S. citizen who is age 21 or older
