

Testing Requirements for New York State Certification

New York State candidates for a **first Initial teaching certificate** in most certificate areas must achieve passing scores on the Educating All Students (EAS) test, the Academic Literacy Skills Test (ALST), edTPA, and the Content Specialty Test(s) (CST) in their area of certification.

Safety Nets for Certain NYSTCE Exams

At its May 2015 meeting, the Board of Regents, by emergency regulation, extended the edTPA Safety Net and created safety nets for the Academic Literacy Skills Test (ALST), Educating All Students (EAS) test, and certain redeveloped Content Specialty Tests (CSTs). Bilingual Education Extension to a teaching certificate	Bilingual Education Assessment (BEA) in the target language of instruction
Candidates seeking a Level I, Level II, Level III, or Pre-Professional New York State teaching assistant certificate	Assessment of Teaching Assistant Skills (ATAS) (Progression from one level to another does not require that a candidate retake the ATAS.)
