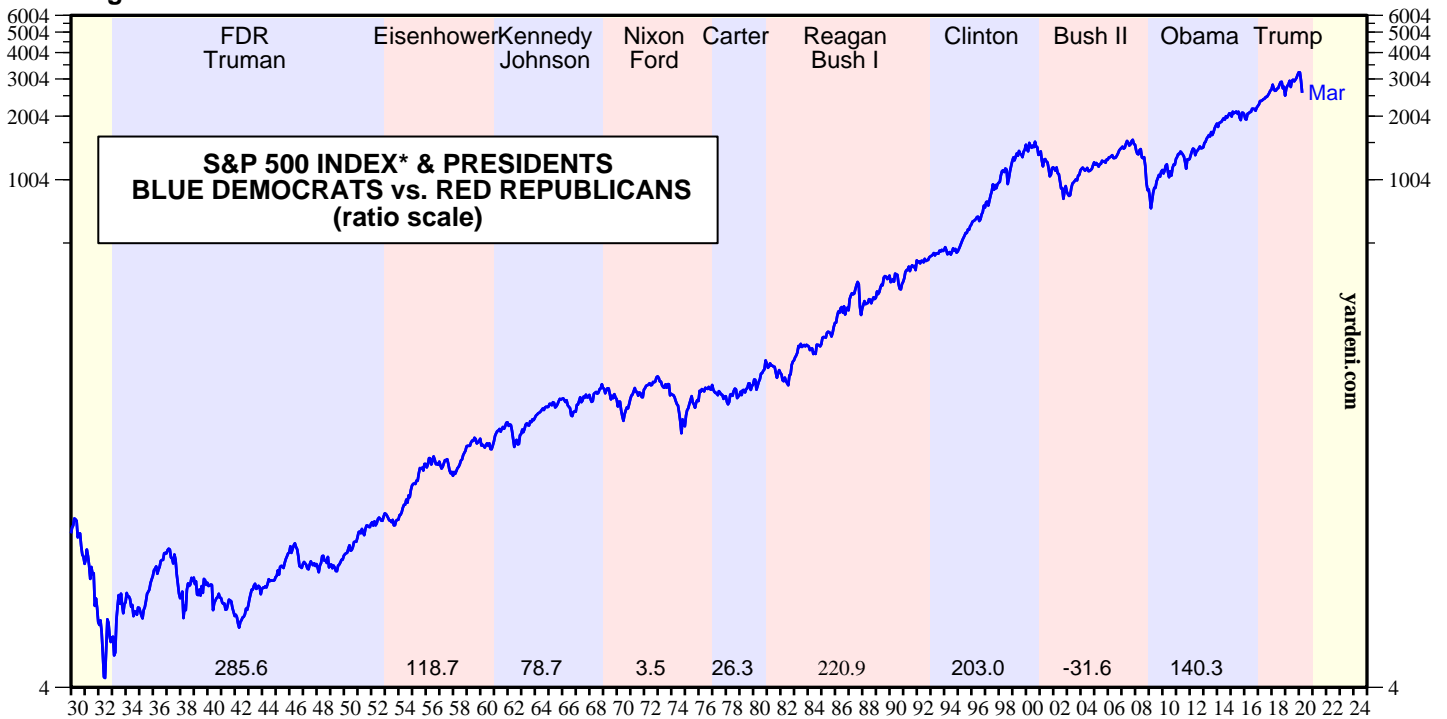

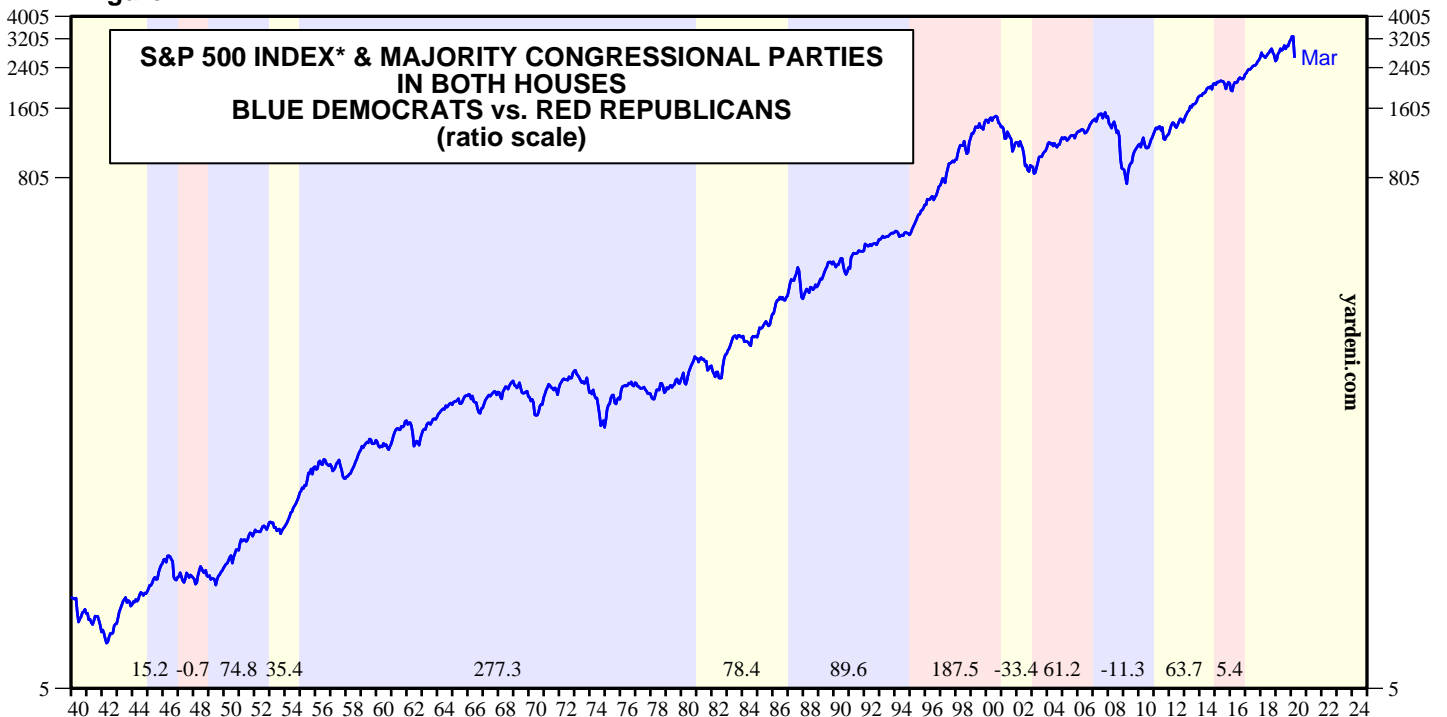

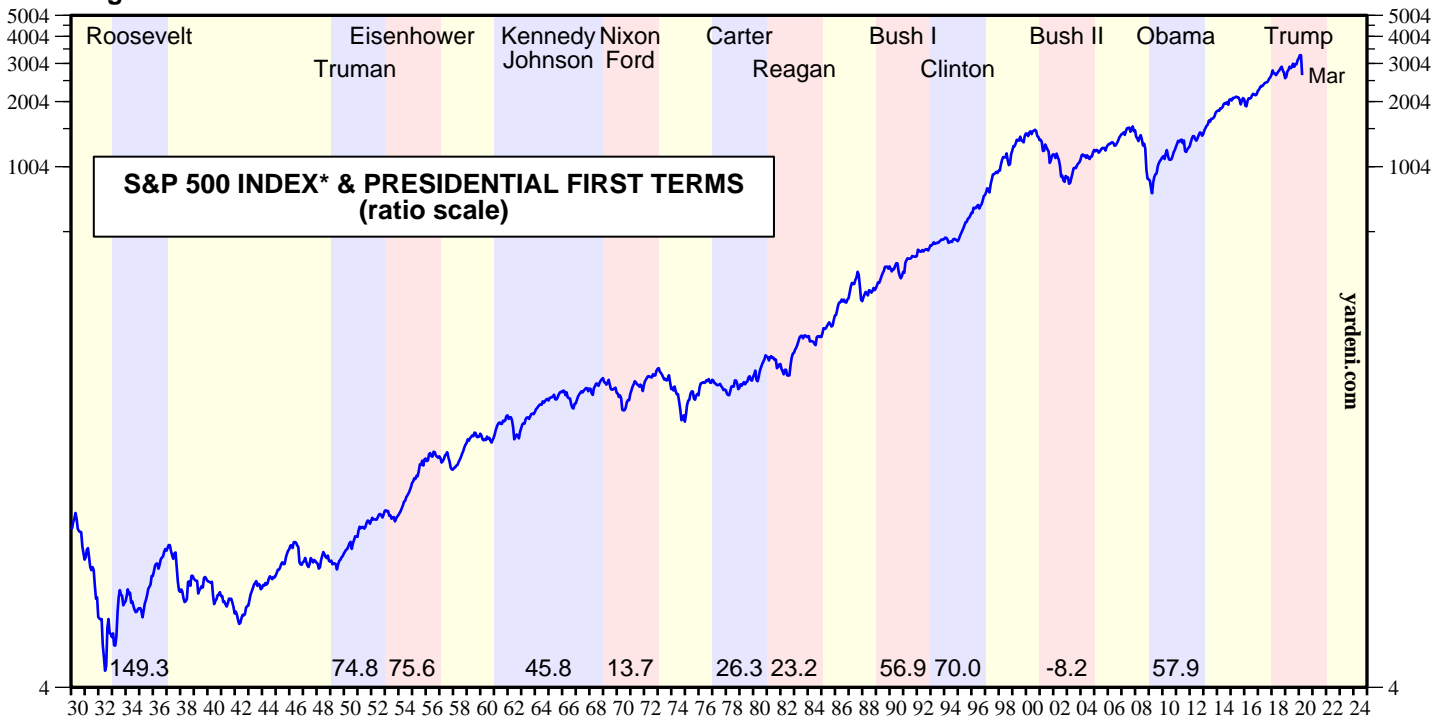

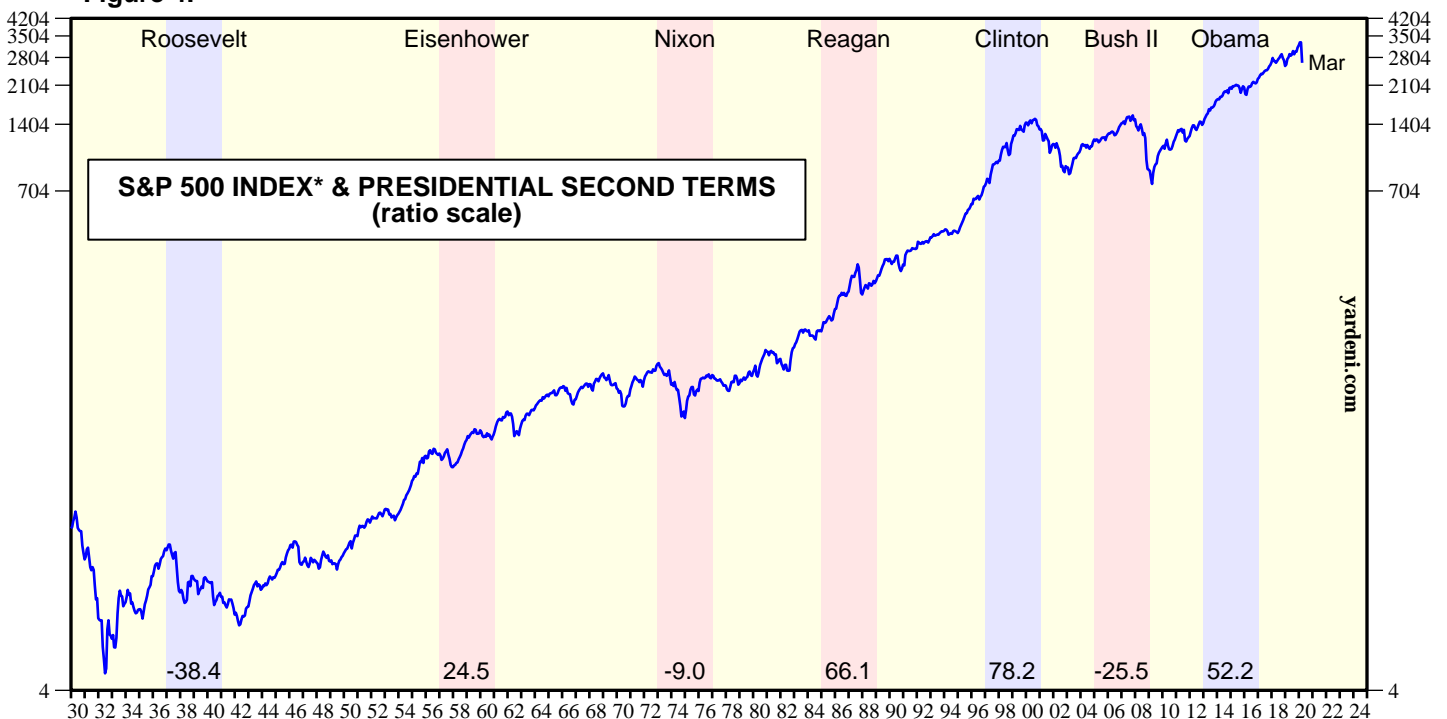

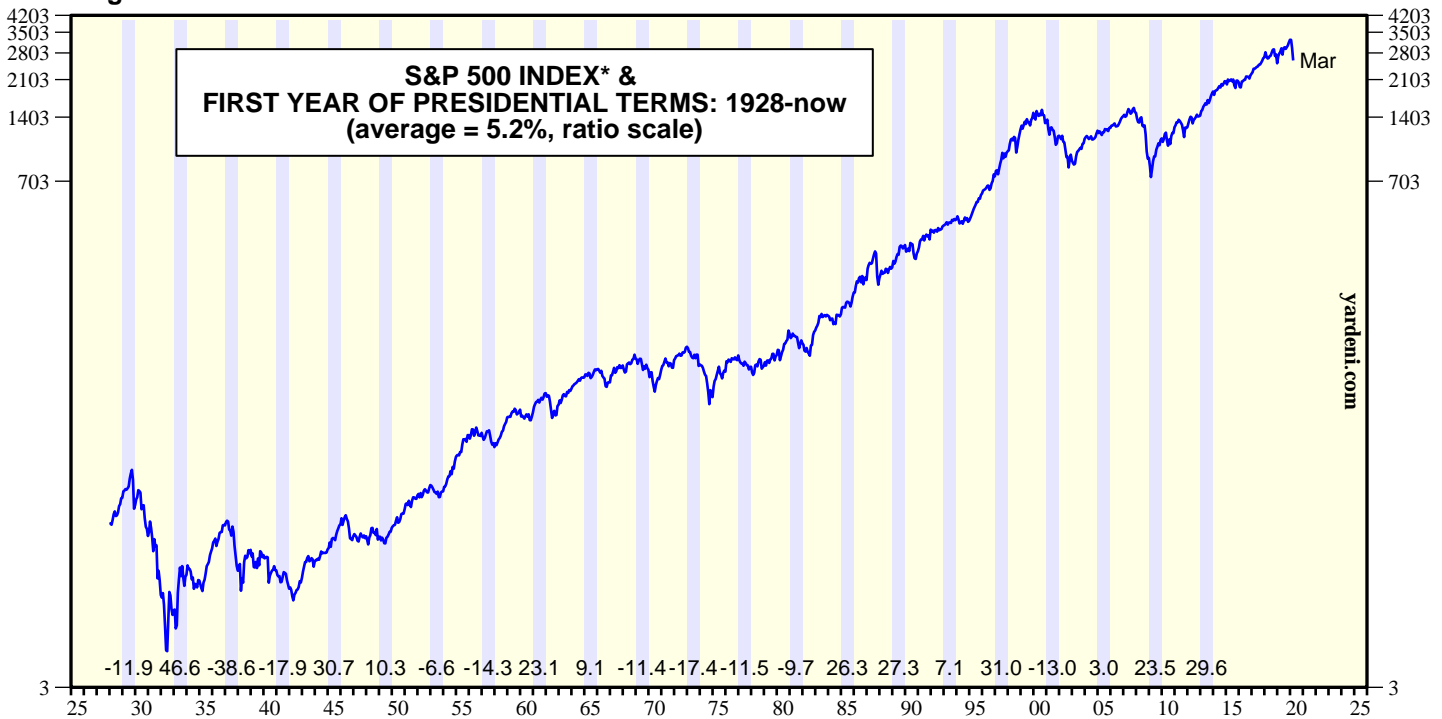

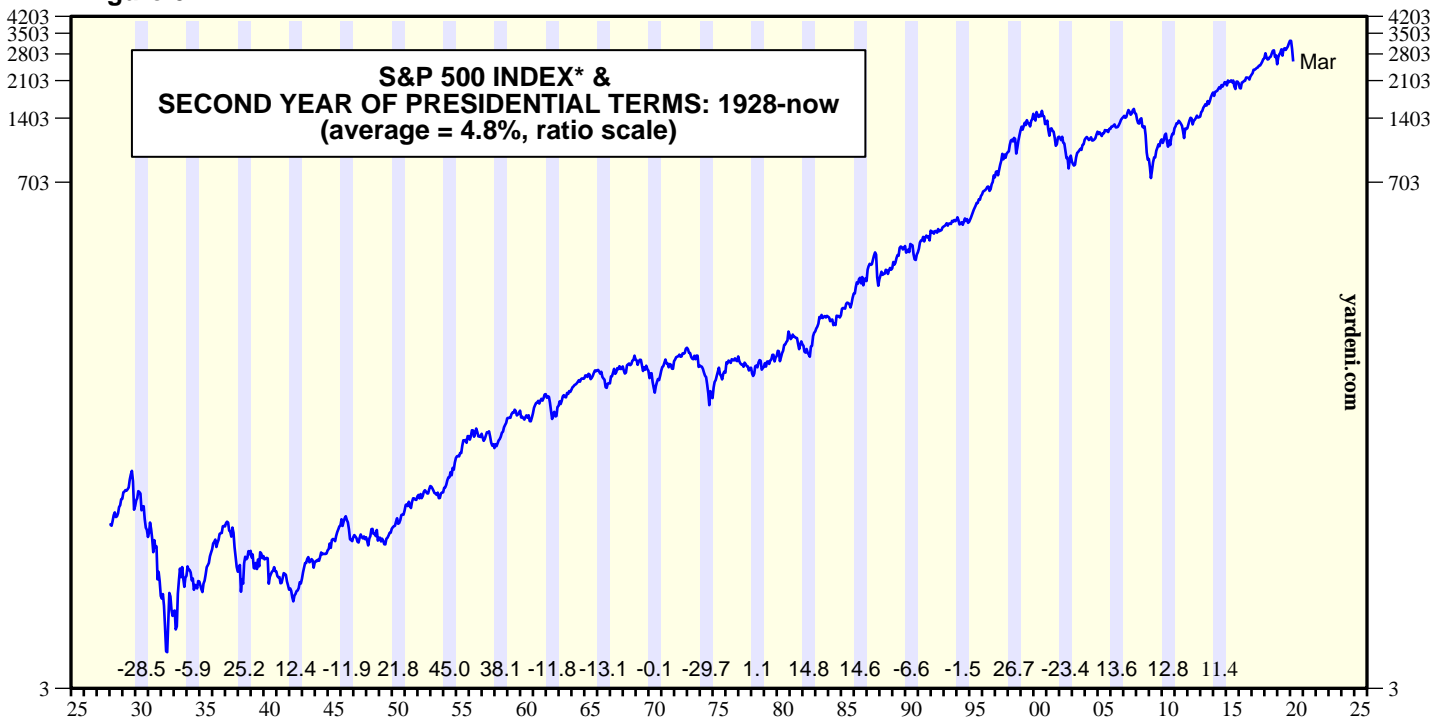

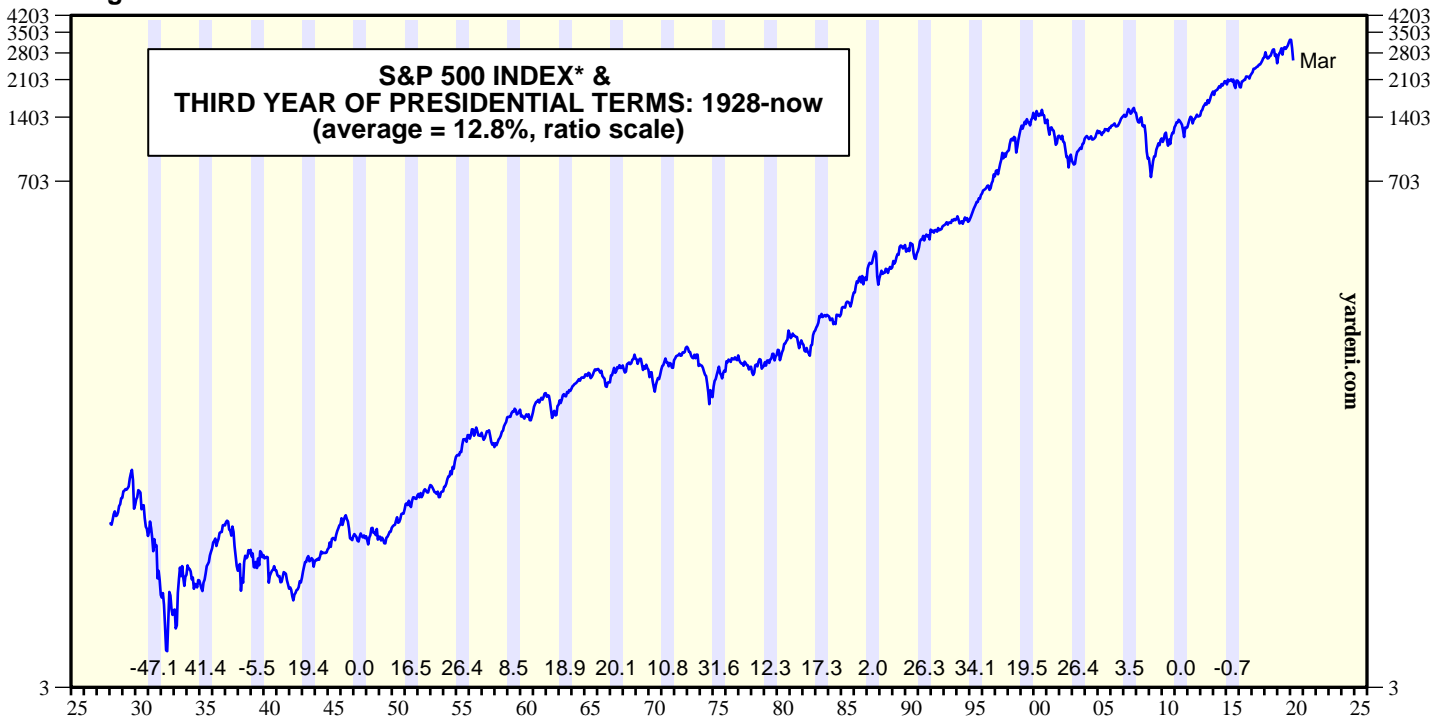

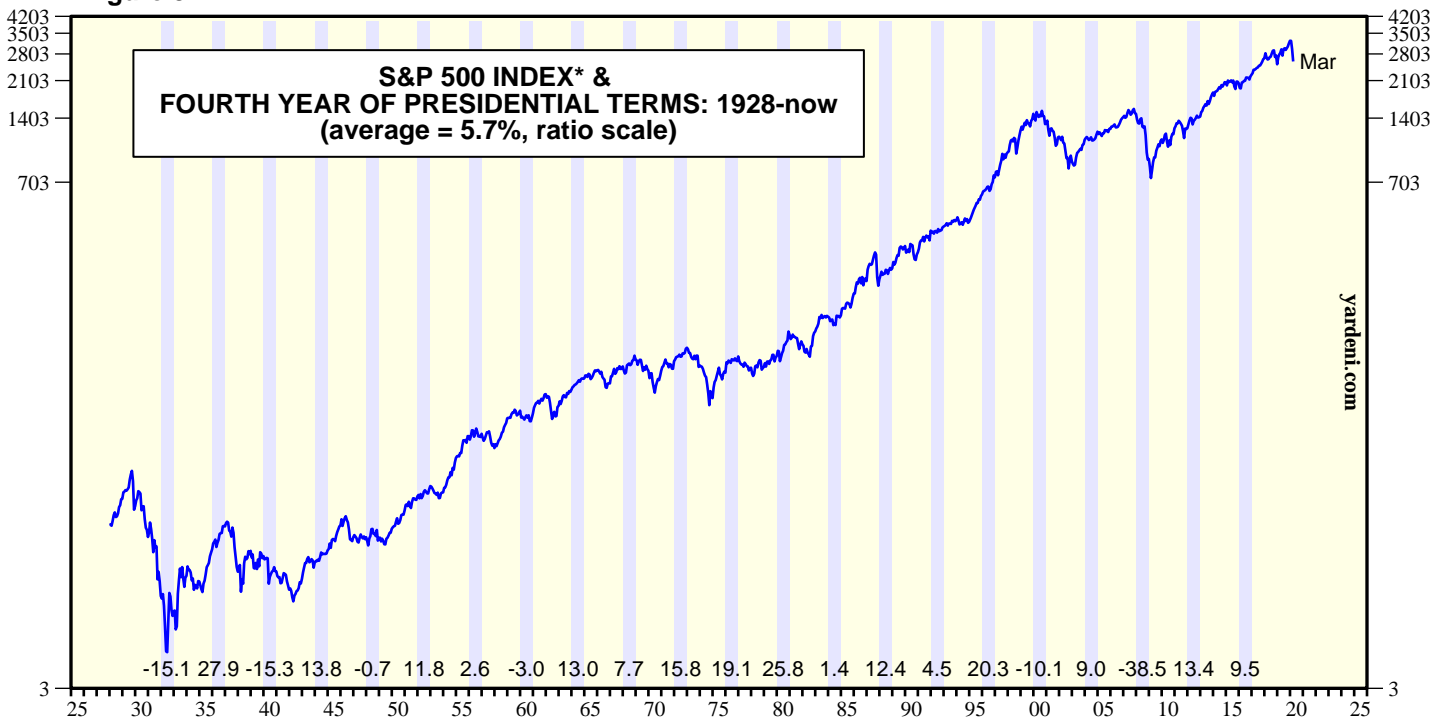

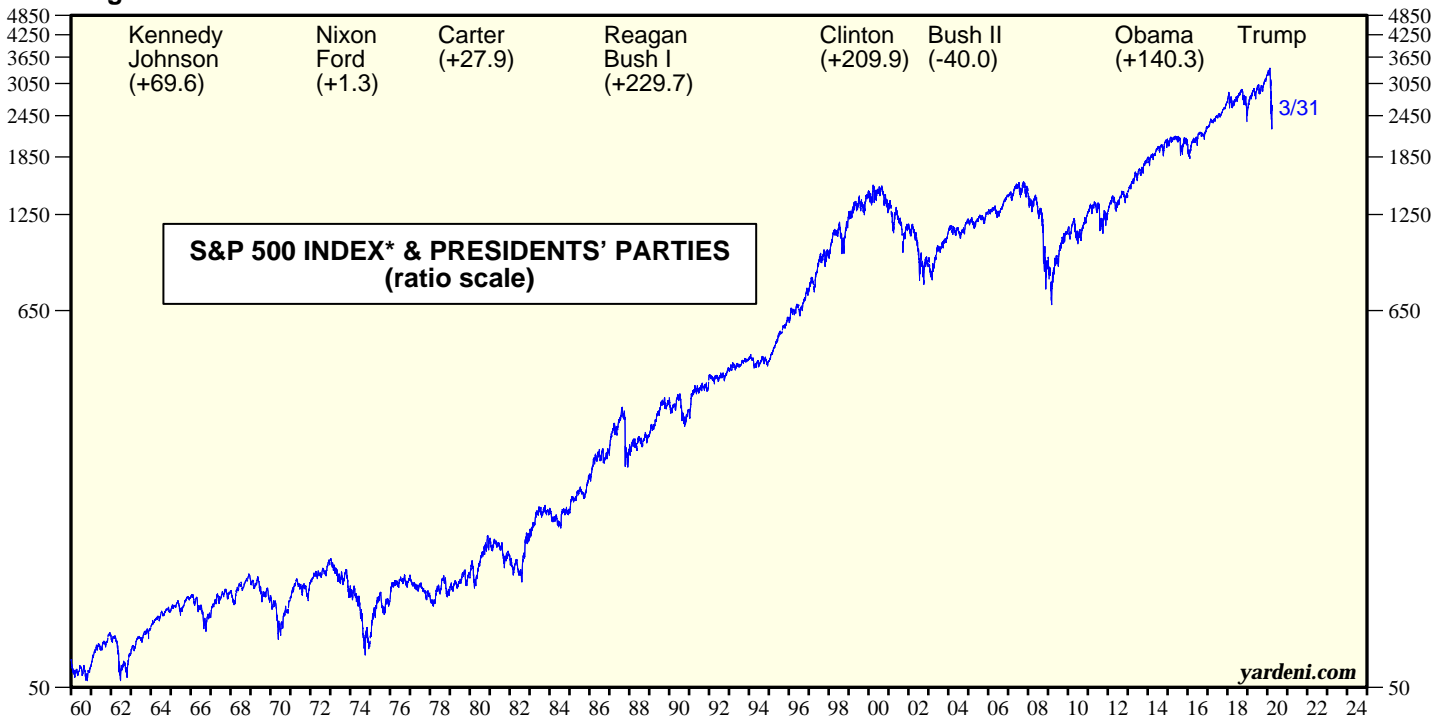

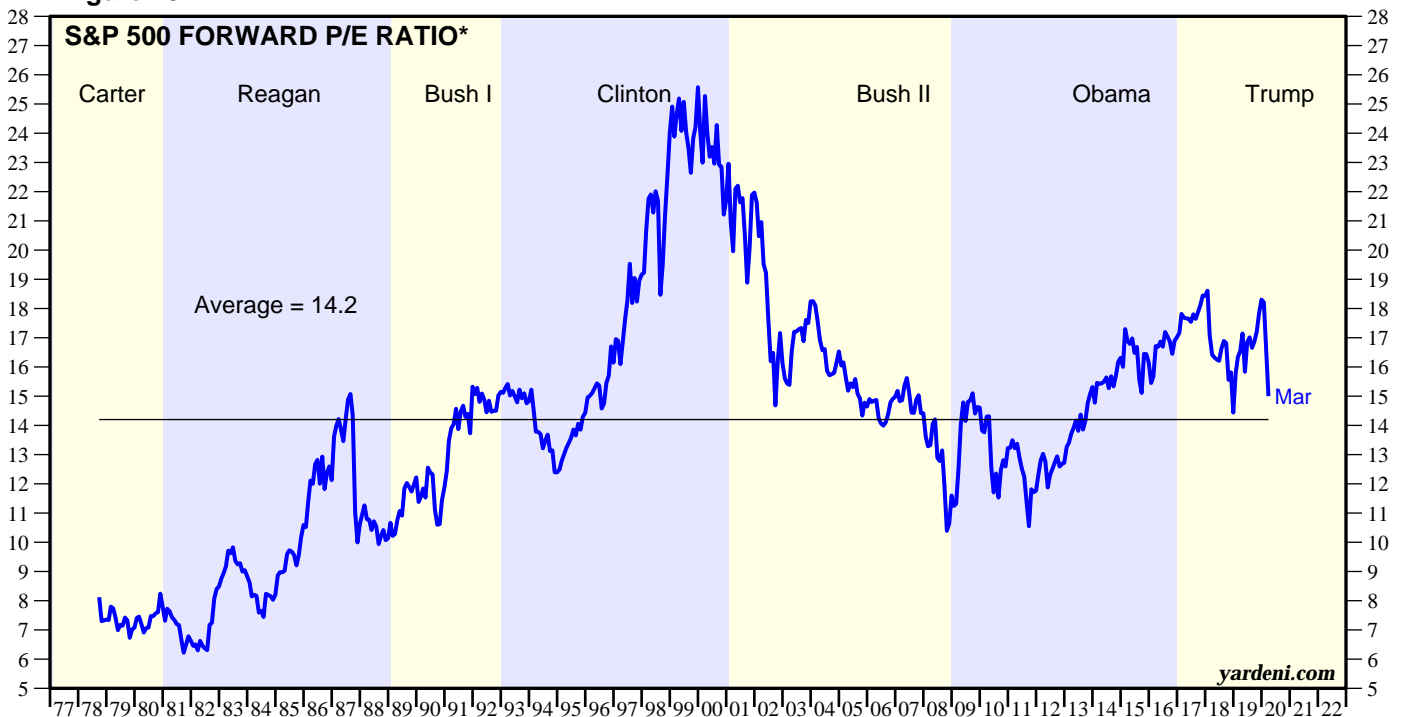

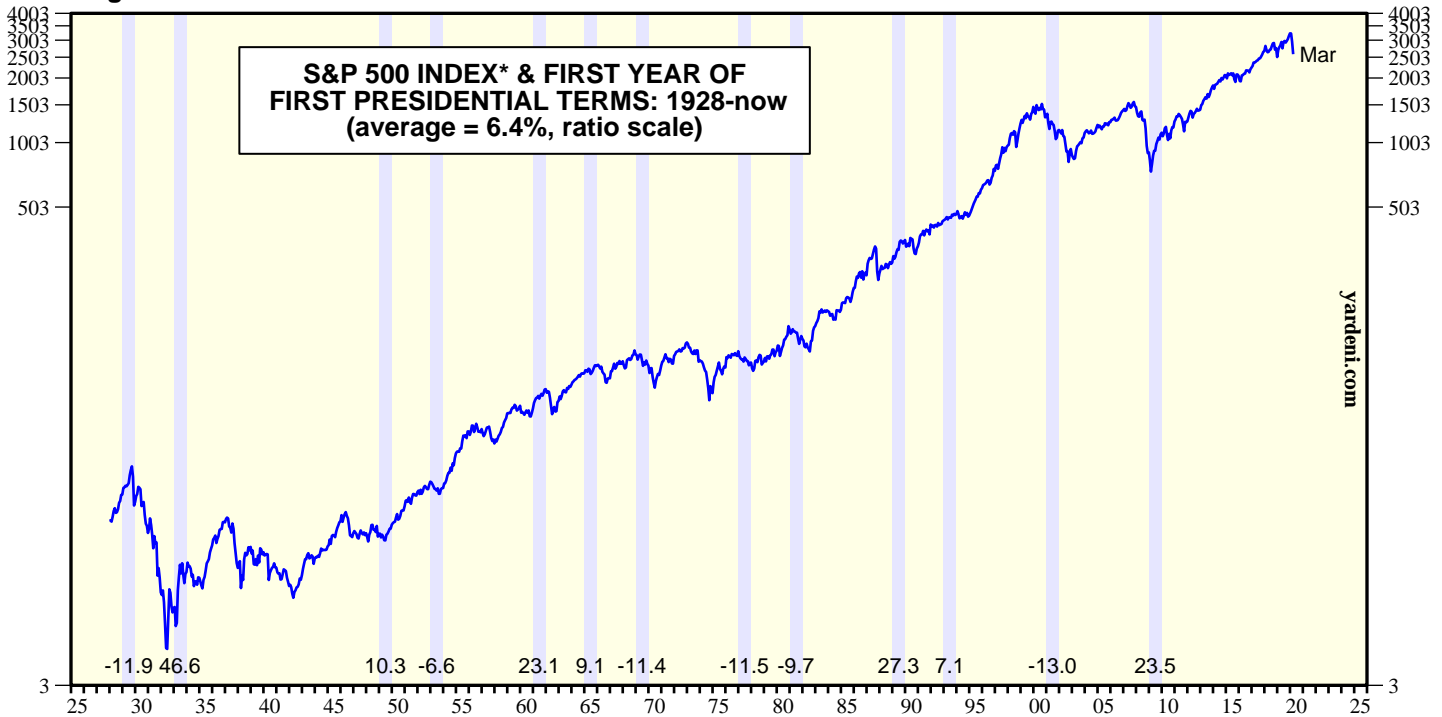

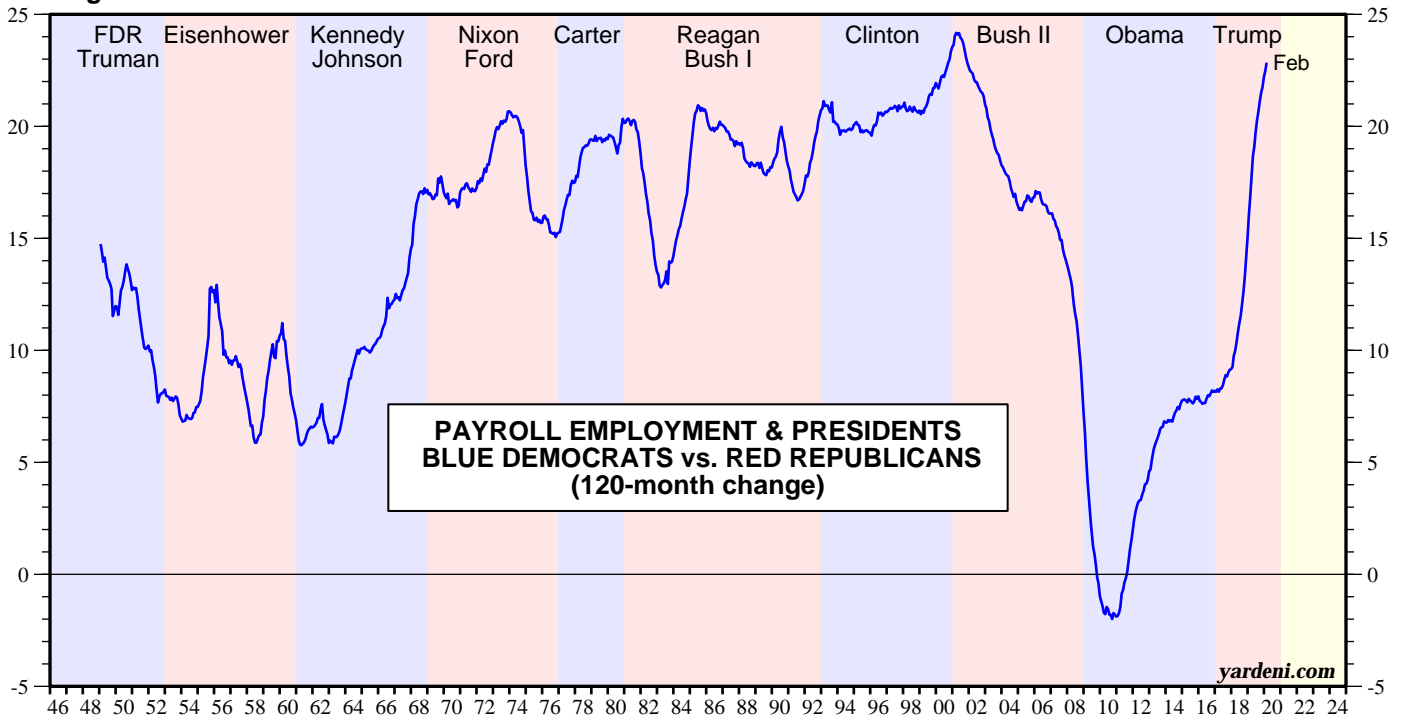

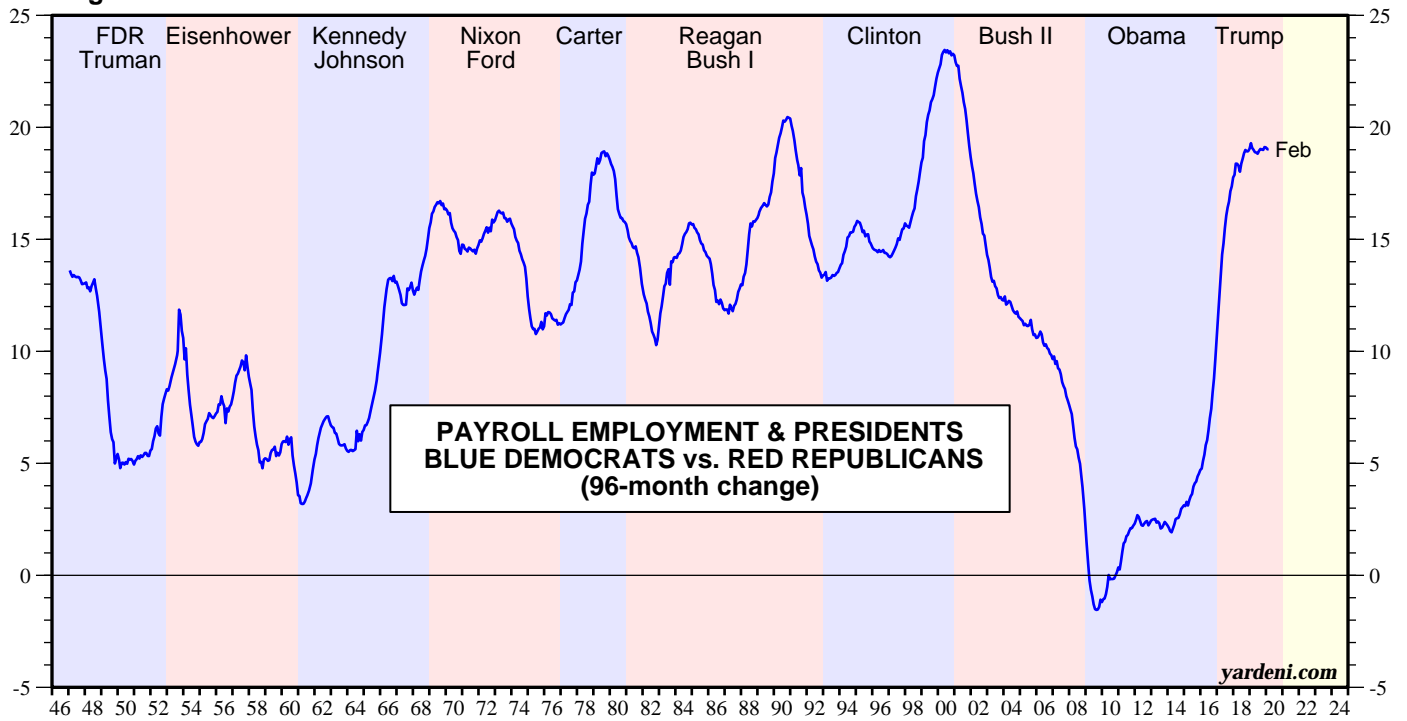


Note: Blue (red) shades represents Democrats (Republicans) in White House.
