Profile Security Updates

Michigan Department of Treasury is committed to keeping your information secure. Beginning January 16, 2018, as MTO users log into their accounts, they will be required to select and provide responses to four (4) security questions. Your responses to these basic questions (such as what is your mother's maiden name?) will be stored and used to assist in self-service password resets and to enhance user security with MTO. While this update is mandatory, it is a one-time event and none of the questions require personally identifiable information (such as social security numbers, driver's license numbers or previous addresses). Protect these profile security answers like your password.

Homepage Redesign Part II featuring User Role Navigation and Medical Marihuana Facilities (MMF) Tax

Account Services is now Tax Services. Each tax role available in MTO has its own Dashboard where you can connect to a Michigan registered business via *Create a New Business Relationship* and also access businesses you previously established a relationship with, allowing you to interact with Treasury.


New Tax Services:

- E-Registration
- Medical Marihuana Facilities (MMF) Tax

MMF tax was enacted in July 2017 and took effect December 15, 2017. The Department of Licensing and Regulatory Affairs (LARA) issues licenses to qualifying facilities and these businesses file and pay MMF tax to the Michigan Department of Treasury on a quarterly basis. MMF is a 3% excise tax on medical marihuana, paraphernalia and all other sales. Businesses subject to MMF tax must be registered with Treasury for sales tax as well.

MMF Tax has also been added to the *Fast File* Guest Service portal.
