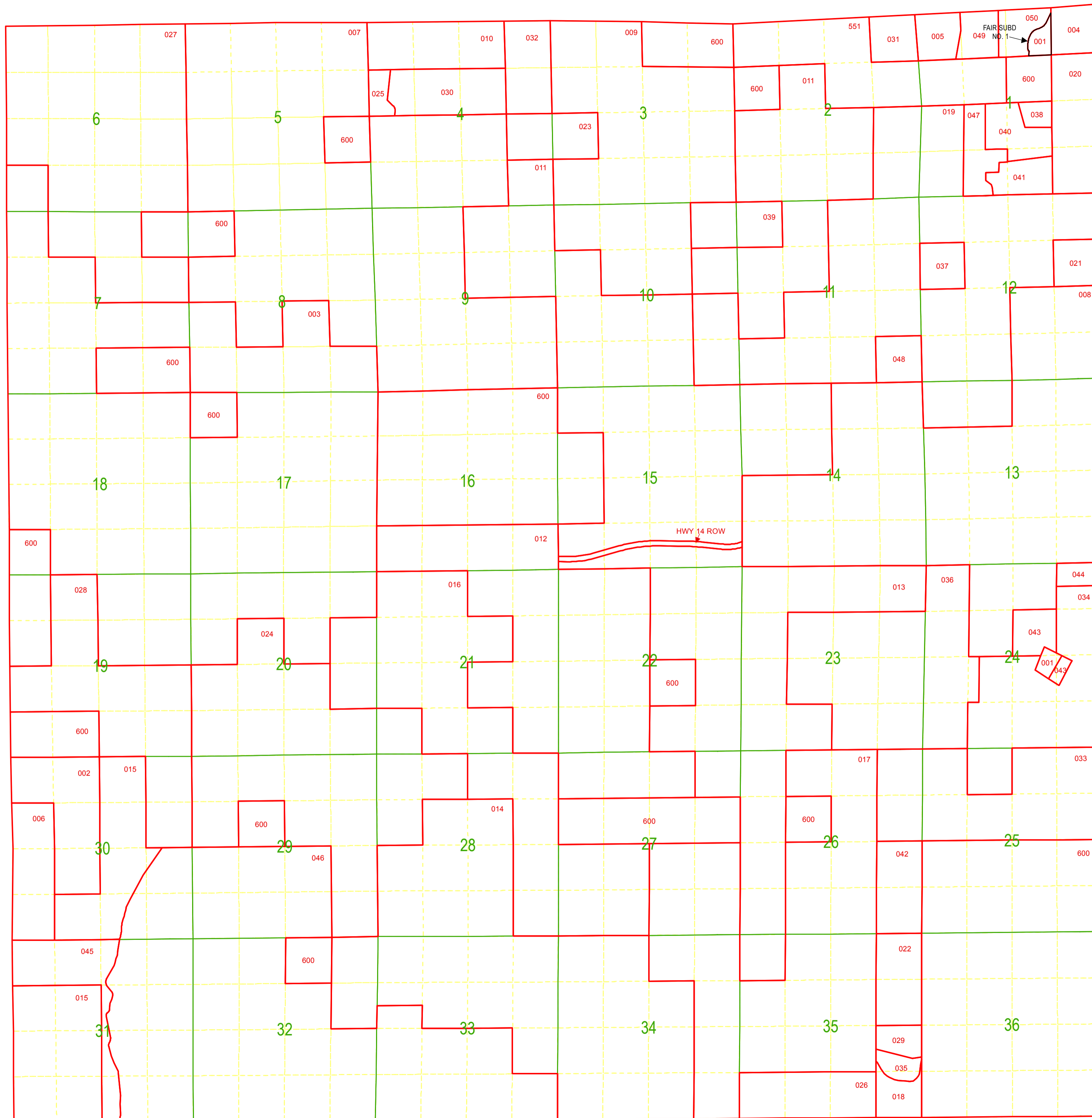


**Disclaimer for use of the Property Ownership Maps**
