

- In lieu of testing and at the request of the client, documentation has been provided which indicates compliance with the lead content requirements of crayons and art supplies of the Consumer Product Safety Commission (CPSC), "Guidance for the determination of extractable lead from crayons and art supplies June 23, 1994."
- The total lead content of 300ppm requirements in substrate materials (Consumer Products Safety Improvement Act (CPSIA) of 2008).
