

## WHAT'S HAPPENING

#### **NFHS Coaches Association Award Program**

We are proud to announce that, again this year, the Board of Control has given TSSAA permission to participate in the NFHS Coaches Association Award Program. This program is designed to recognize State Active Coaches of the Year and Sectional Coaches of the Year in each sport sanctioned by the Association. Coaches are selected based on their accomplishments the previous school year. State and Sectional Coach of the Year winners will receive a certificate from the National Federation recognizing their accomplishments. Sectional Award winners will also be considered for the NFHS National Coach of the Year Award. A National committee will select the National Coaches of the Year and these individuals will receive a plaque from the national office recognizing their accomplishment. Each state is also allowed to nominate one Citation (Coach) nominee. NFHS Citations are presented to individuals who have made significant contributions to the NFHS and/or other national organizations that have had an impact on high school activities. Nominees for Contributor of the Year must exemplify the highest standards of sportsmanship, ethical conduct, moral character, and carry the endorsement of their respective state high school association.

The following criteria was used to select the National Coach of the Year: career coaching record, community service, involvement in school activities, involvement in the individual's profession at the local, state, and national levels, and the individual's basic philosophy of athletics.

Congratulations to all of our state and national honorees. This is a tremendous accomplishment and each recipient is very deserving of these accolades.

#### **Website Usage Update**

Biggest day for website uses: 60,000 visited to get football playoff brackets. The next five biggest days of the fall for website access were weeks 1 through 5 of football playoffs, with 30,000 visits for the Friday BlueCross Bowl games.

TSSAA has 3,680 followers on Twitter

Mobile devices (tablets and smart phones) now make up 33% of all access to TSSAA.org

Internet Explorer is still most used browser to access TSSAA.org with ever declining number - now at 40%.

30% of all traffic to TSSAA.org comes from users directly entering TSSAA.org through their browser. Another 30% from Google search referring. The rest mostly come from links such as Yahoo, Bing, and Coacht.com.

Access to the TSSAA website came from 218 Tennessee locations, and all U.S. States. The state that TSSAA.org received the least amount of visits (46) from Wyoming, almost all from Lander.

From outside of United States, there was a lot of access for football playoffs from Canberra, Australia (the capital of Australia). It is located in New South Wales province.

## DISTINGUISHED SERVICE RECOGNITION

#### **ADMINISTRATOR - Turner Jackson**

TSSAA is proud to recognize Turner Jackson as its Distinguished Service honoree as an administrator. Turner graduated from Butler High School in Huntsville, Alabama. While in high school, he was a two-time state wrestling champion. Turner went on to wrestle at the University of Chattanooga.

Coach Jackson took over the Bradley Central wrestling program in 1979. He was named athletic director in 2002, and continues to hold that position today.

Turner is married to the former Liz Hannah, who was also a stand-out athlete. Turner and Liz have two daughters, Brittany and Lindsay.

#### **OFFICIAL - Mike Craft**

Mike Craft is a TSSAA veteran wrestling official of 37 years and a former NCAA wrestling official. During Mike's tenure as a TSSAA official, Mike has been selected to work numerous finals matches in the TSSAA Individual and Dual Meet Tournaments. He continues to grade out as one of the top wrestling officials in the state of Tennessee. Mike was a high school wrestling state champ at Anniston High School and continued his wrestling career at UTC. Mike received the Most Improved Wrestler Award while at UTC in 1974. One of Mike's biggest thrills was watching his son Josh win a state championship while wrestling for East Ridge High School. Josh has followed in his father's footsteps and is now a polished wrestling official with the Chattanooga Wrestling Officials Association.





#### **COACH - James Counce**

TSSAA is proud to recognize James Counce as its distinguished service honoree as a coach.

James Counce played football at South Fulton High School and Murray State University before embarking on a coaching career at Ohio County, Kentucky, and Marshall County Kentucky. He then became an assistant coach at Henry County High School in the mid-1970s.

After leaving Henry County High School, Coach Counce was head coach at Camden for a year before spending 11 years at Dyersburg. He left Dyersburg for a one-year stint as an assistant coach at Montgomery Bell Academy in Nashville before returning to Dyersburg as head coach in 2008. He retired after leading Dyersburg to a 10-3 record the 2008 season, but could not turn down a chance to return to Henry County.



Counce spent 40 years coaching football and has an overall record of 185-90. He was named the Tennessee Titans Coach of the Week twice and won several Coach of the Year awards. He also served as an assistant coach in the Tennessee vs. Kentucky All-Star Game in 2004 and 2005, and was the head coach for Tennessee in 2006.

Coach Counce was married to Donna Marie Counce for 36 years until her death in 2007. He has one son, James Counce III, and three grandchildren, Caleb, a freshman at UT Martin, Matthew, a freshman at Henry County High School, and Rylee who is in the second grade at Rhea Elementary School. His hobbies include hunting and fishing.

Chip Cirillo was born in Cleveland, OH. He moved to Cherry Hill, NJ as a young child, then grew up near Chicago where he played football in high school. From there, he attended the University of Illinois.

Shortly after he graduated from college he moved to Middle Tennessee and started working in the newspaper business. He worked for several newspapers, including the Leaf-Chronicle in Clarksville before joining The Tennessean in 1996. He has held various jobs at The Tennessean, including covering high school sports, helping cover the Nashville Predators and working at the Williamson AM.

Chip has been focused on covering high school sports since 2009. Chip has become a fixture on press row at pretty much every state championship event throughout the school year.

## 2011 A. F. BRIDGES AWARDS 2012

As part of the "JUST DO WHAT'S RIGHT!" program, TSSAA recognizes member schools that have made the effort to remind their athletic family that there is a particular code of conduct, a particular level of expected behavior, and a way to act that is proper if one wishes to be a part of an athletic contest, regardless of how they participate.

"JUST DO WHAT'S RIGHT!" focuses on the foundation of what we hope all participants will do. Just do what you are supposed to do in representing yourself, your family, your school and community.

Those schools that received no reported unsportsmanlike conduct incidents during the 2011-12 season have received a certificate highlighting the "JUST DO WHAT'S RIGHT!" logo and this effort. We are specifically recognizing proper sportsmanship at athletic contests, but we all understand that the athletic contests are a small part of our educational program.

#### **DIVISIONAL AWARDS**

Local officials associations have been asked to nominate schools that they service that have displayed this overall positive effort to teach, expect, and demand a positive atmosphere of sportsmanship at their particular contests. Member schools have also been asked to nominate individuals or schools for special recognition for going the extra mile to do what's right. Nominations have also come from representatives of the Tennessee Obervers Program for Sports. The TOPS observers have shared the positive efforts that have been recognized at athletic contests across our state.

From these nominees and the schools that have received no reported unsportsmanlike conduct during the previous school year, 27 schools have been selected to receive the A.F. Bridges Award at the divisional level. Three Class A, three Class AA, and three Class AAA schools in each grand division have been recognized for a total of nine schools in each division and 27 schools overall. These schools will be presented "JUST DO WHAT'S RIGHT!" recognition banners at the regional meetings in each grand division of our state during November. Again, the TSSAA Board of Control has earmarked \$27,000 toward a scholarship fund to recognize outstanding student athletes from the A. F. Bridges Divisional Finalists. Each school will receive \$1,000 toward a scholarship to recognize an outstanding student athlete who represents the essence of good sportsmanship and citizenship. The criteria for this scholarship will be established by the school, and student athletes will be recognized later during the school year.

#### STATE AWARD OF EXCELLENCE

Of these 27 divisional recipients, one school in each class will receive Tennessee's top award for overall outstanding effort in its division. These schools will be presented the A.F. BRIDGES STATE AWARD OF EXCELLENCE. This is the highest award that can be bestowed upon a school to honor its overall efforts to promote citizenship and sportsmanship at school, and at athletic contests.

#### ATHLETIC DISTRICT AWARDS

The A.F. Bridges Awards program includes awards for School System Administrator of the Year, Principal of the Year, Athletic Director of the Year, Female Coach of the Year, Male Coach of the Year, Official of the Year, and Contributor of the Year. Recognition will be made in the above mentioned categories in each of the nine athletic districts in our state. Nominations have been made by a Citizenship/Sportsmanship Committee in each athletic district and final selection has been made by a State Selection Committee.

The awards are named the A.F. BRIDGES AWARD in honor of the TSSAA's first executive secretary.

#### A.F. BRIDGES

A.F. Bridges was born in Athens, Louisiana on March 17, 1905. He attended school in Lincoln County, Tennessee and graduated from Central HS in Fayetteville in 1922. He earned his B.A. and M.A. from Peabody College in Nashville. He began his work as a teacher and coach at

Peabody HS in Trenton, and after a number of years with the Milan, Henderson, and Covington schools, he returned in 1936 as Superintendent of the Trenton schools. Soon after, he became the Superintendent of the Covington City Schools. After three years in Covington, Mr. Bridges was named as the first full-time Executive Secretary of the Tennessee Secondary School Athletic Association and established the first TSSAA state office in Trenton in 1946. Under the leadership of A. Foster Bridges, athletics in the state of Tennessee reached a level of excellence and competence that earned the respect of all people. Mr. Bridges brought national recognition to Tennessee in HS athletics, and particularly in the field of girls' athletics and in the establishing of one of the most respected training programs for officials in the nation.Mr. Bridges was a person of high principles who displayed firmness and fairness, as well as the high ideals of ethics and integrity, as he and many other school people established the foundation of TSSAA across our state. It is our sincere wish that through honoring Mr. Bridges by naming this awards program after him, we will have the opportunity to remind young people of the positive characteristics, not only of this gentleman, but of athletics in general and participants specifically.





## TMSAA REPORT



The Tennessee Middle School Committee met for the first time this school year on November 14th. Members in attendance were Chic Nute, Vic King, Ken Hilliard, India Weaver, Tim Bell, Matt Calvert, and Jason McKinney. Mr. McWhirter welcomed new committee member, Jason McKinney. He represents the Chattanooga area.

Committee members were given a list of new member schools, and they decided on the appropriate Area for each new school. Unaka Elementary School will be classified as East TN

Area 1 A; Grand Junction Elementary School, Adamsville Elementary School, Summertown Elementary School, Coulter Grove Intermediate School, and Montgomery Ridge Intermediate School are only participating in cooperative programs; Westwood Middle School will be placed in Middle TN Area 4 AA; Southern Avenue Middle School and Grandview Heights Middle School will be classified in West TN Area 1, and their class will be determined after their enrollment numbers are confirmed.

The committee discussed setting the classification for the next four years. The TSSAA state office will provide the committee with the 7th grade enrollment number that are turned into the state by the schools in January. Using those numbers, each area of the state (east, middle, and west) will set their classification. East TN and Middle TN will have three classes each and West TN will have two classes. The new classification will be set in April, and the classification period will be for four years, keeping in line with the high school association. Schools will only be allowed to move up or down within that period if they appeal the TSSAA state office and have a 20% increase or decrease in their enrollment numbers.

The TMSAA Committee discussed why schools do not join the TMSAA in certain areas of the state. The Independent Game Rule once

again came up for discussion. Mr. McWhirter asked the committee members to bring more feedback from their schools to the next meeting. Other issues brought up were: member schools and who they can play, schools must join the association for all sports that they recognize, and there is a lack of tournaments for some sports in parts of the state. Mr. McWhirter and Mr. Bell plan to meet with system-wide athletic directors in Middle Tennessee to discuss these issues further.

It was asked that the committee members submit their area and sectional basketball information to the TSSAA state office as soon as possible, so it can be posted on the website.

The Committee reviewed the TMSAA Sports Calendar. All agreed that the changes made last year make the calendar easier to follow. Chic Nute proposed increasing the number of games allowed in softball and baseball from 16 to 18. The committee approved the proposal, and it will be brought before the TSSAA Legislative Council at their December meeting. The committee was reminded that tournaments count as 2 regular season games for all sports. However, the season-ending tournament does not count against the number of regular season games that are allowed. The committee agreed that if the high school sports calendar changed its wording from, "Monday, week of..." to "Saturday, week of..." they would recommend that the middle school calendar be changed as well.

The Committee reviewed the TMSAA Bylaws. No proposals were made at this time. They did discuss the possibility of the Coaches Education Program moving entirely online through the NFHS, rather than having a component of the program in a classroom setting. If this were to occur, the course would cost less, and it would be easier for coaches to take the class because they would not have to reserve a spot and travel. The possibility of non-faculty coaches being required to complete the course prior to beginning coaching rather than having 5 years to complete the requirement was also discussed.

Mr. McWhirter will have the proposed state-wide officials pay scale for middle school sports available for committee members at the next TMSAA meeting.

The next TMSAA Committee meeting is set for February 13, 2013, at 9:00am.
