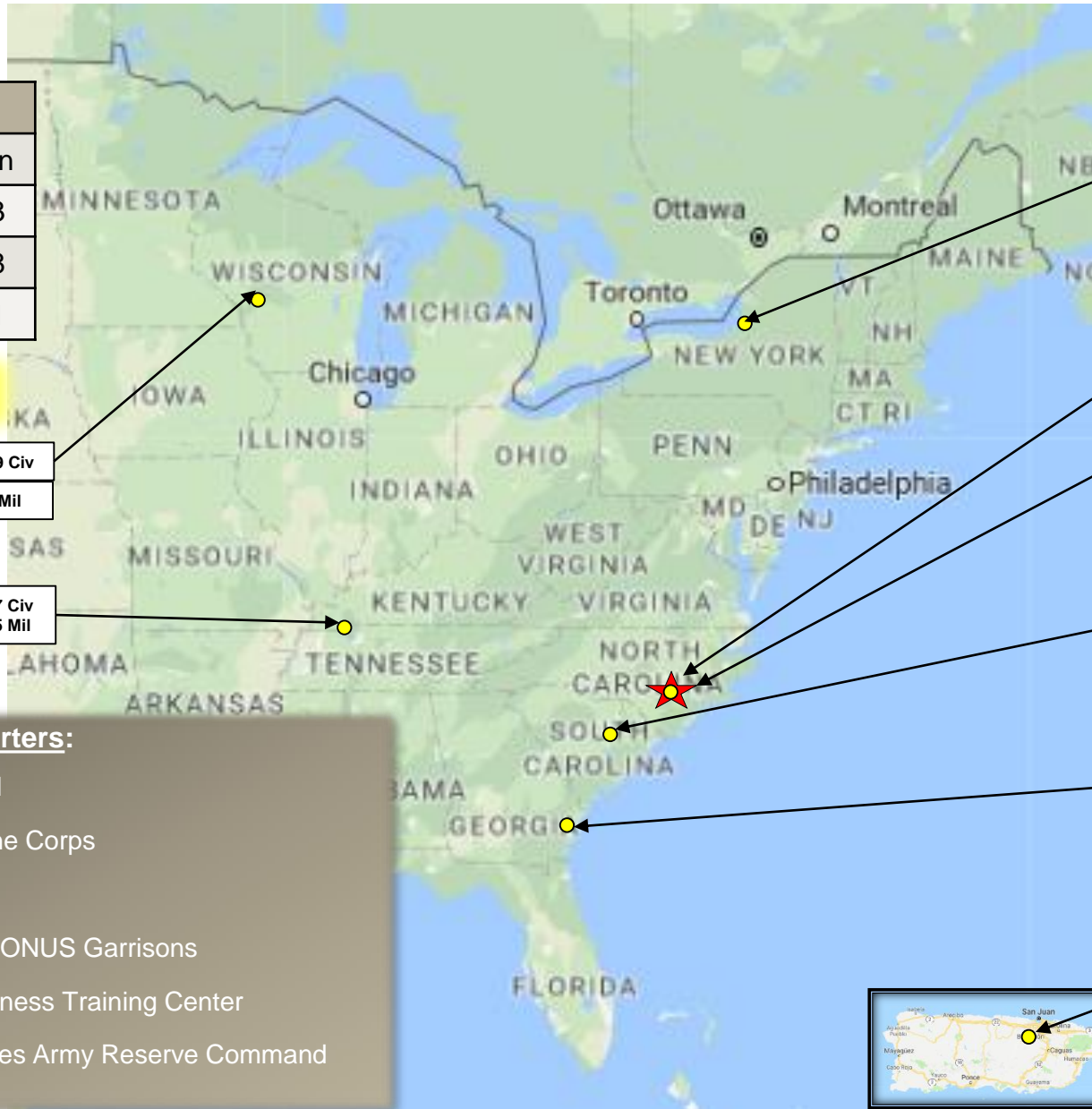

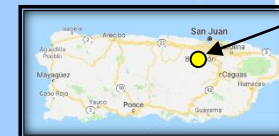

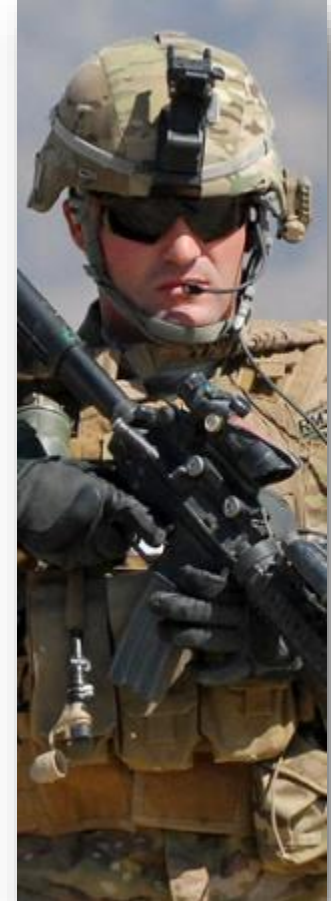

Government Purchase Card

✓ **Micro-Purchase Thresholds (Maximum)**

- Construction- Purchases covered Construction Wage Rate - \$2,000.00
- Services- Purchases covered by Service Contract Labor Standards - \$2,500.00
- Supplies - \$3,500.00 (up to \$5,000.00 with approval)

✓ **Other Thresholds**

- Ordering Officer (Supplies Only) - \$25,000 through use of pre-priced government contracts and agreements established contract vehicle with quotes via electronic means.
- Training – Commercial of the Shelf (COS) and Education - \$25,000
 - Training cards will have ALL merchant category codes (MCCs) blocked except the following sources of training:
 - 7392 - Management, Consulting and Public Relations Services
 - 7399 - Business Services (Not Elsewhere Classified)
 - 8220 - Colleges, universities, junior colleges, and other professional schools
 - 8241 - Correspondence schools
 - 8244 - All business/secondary schools
 - 8249 - Vocational/trade schools
 - 8299 - Schools and Education Services (Not Classified)





Government Purchase Card

✓ Tax Exempted

- Items purchases for official U.S. Government purposes with the Government Purchase Card (GPC) are exempt from state tax in EVERY state

✓ Unauthorized Merchant Category Codes

- Based on MCCs, various classes of merchants have been blocked from doing business with the Army through GPC. The unauthorized MCCs are:
