








 Associates are always 100% vested in the value of their contributions, subject to any investment gains or losses.



- Vesting | Employer Matching Contributions
 Advantage will match 50% of the first 6% of your pay that you contribute to the plan annually (Includes pre-tax 401(k) and post-tax (Roth 401(k)).

Vacation Days

Newly hired, regular full-time associates become eligible to accrue vacation time upon the conclusion of the 90-day introductory period. The amount of vacation hours full-time associates are eligible to accrue each calendar year increases with the length of their employment as shown in the following schedule.

Calendar Years of Service	Daily Accrual Rate	Maximum Accrual per Calendar Year
Year 1*	.219	60 Hours
Years 2 - 4	.219	80 Hours
Years 5 - 9	.329	120 Hours
Years 10 and more	.438	160 Hours

^{*} The calendar year in which your employment begins



Sick-Daze

Newly hired, regular full-time Associates become eligible to receive sick-time compensation upon the conclusion of 90 days of service¹




