- Manufactured Home pickups are **Monday through Friday from 8:00a.m. to 3:00p.m.** by appointment only. ***NO PICKUPS allowed the day following the close of the sale***
- Condition of sales units is not warranted. Other parts may be broken or missing and other repairs may be required in addition to those already listed in the GSA description.
