Standards for Suppliers

The Standards for Suppliers are Wal-Mart Stores, Inc.'s fundamental expectations of its suppliers related to social and environmental conditions in all our markets. Federal Taxpayer Identification number (TIN)

Suppliers must have a current Federal Taxpayer Identification Number (TIN) to do business with Wal-Mart Stores Inc. http://www.irs.gov/Individuals/International-Taxpayers/Taxpayer-Identification-Numbers-(TIN)

Dun & Bradstreet Registration (D&B)

If you do not currently have a D&B number, please contact D&B at 1-866-815-2749 to register. Please have your D&B information up-to-date before submitting your application. Suppliers with a risk rating of 7, 8, or 9 will not be considered.

Insurance Requirements

Product Safety and Compliance

Product Safety and Compliance programs identify, mitigate and monitor risk associated with general merchandise. You will be required to submit all product test reports as well as your General Certificates of Conformity (GCC).
