## **LESSON 5 INSTRUCTION MANUAL**

NOW THAT YOU HAVE SET UP A "UCC-1" AGREEMENT W/ YOUR SECRETARY OF STATE, NOW IT'S TIME TO INFORM THE TREASURY, WHO HOLDS YOUR "TREASURES", THAT YOU'VE CONTRACTED WITH THE SECRETARY TO CLAIM BACK YOUR POSSESSIONS.

**First Treasury Package Mailings:** Now you are Establishing Your Foreign Situs Trust with the Treasury to create a UCC CONTRACT **TRUST ACCOUNT**. It's literally a UCC CONTRACT "agreement" with the Secretary, allowing you permission to set up your Foreign situs TRUST ACCOUNT with the Treasury! The Treasury and Secretary work on YOUR behalf to discharge your commercial Obligations/Charges brought against you!

Its CRUCIAL TO REMEMBER to Ship this package via "Registered Mail" and remember this number FOREVER. It will serve as your deposit "Account Number" with the U.S. Treasury for your future Presentments to Discharge Obligations. Second Treasury Package: UCC-3 & Funding Our UCC Contract Trust Account with our Birth Certificate Bond - In this section, you will fill out the templates for a Verified Actual Constructive Notice, International Bill of Exchange for \$200 Billion, Lawful Order for Money for \$200B, Clear Copy Birth Certificate, AFV Birth Certificate, and Chargeback Birth Certificate which are to be placed on a UCC-3 amendment Filing as "Adding Collateral". Doing this will "Register" these instruments and add them on to your Initial UCC-1 Filing. Also Don't forget to *list Document NAMES & NUMBERS* of those templates on the UCC 3 As well. Then mail the certified copy UCC-3 to the Secretary of the Treasury. ACTUALLY READ THESE DOCUMENTS AND ABSORB WHAT THEY ARE SAYING!!!

K. Lawful Order for Money - This form is to have the Birth State and/or USCIS to secure your interest in your master bond.

- L. Re-Attach Affidavit of Tax Exempt Foreign Status from previous package
- M. Re-Attach Revocation and Termination of Franchise from previous package
- N. Master Discharge and Indemnity Bond This security instrument is your master bond which is collateralized by your birth certificate and / or naturalized certificate that goes on deposit into you post registered deposit account. The Amount should be for \$200,000,000,000 (Template: <a href="https://drive.google.com/file/d/0B0tJIYKPFQ-8b09CSUtNWUFzdEE/view?usp=sharing">https://drive.google.com/file/d/0B0tJIYKPFQ-8b09CSUtNWUFzdEE/view?usp=sharing</a>) . You can take off the Border, and buy a Real Certificate from Office Max and Print it on that to look more crisp and professional (Not Mandatory though).
- O. Re-Attach Your Security Agreement from previous package
- P. Attach the UCC-3 Filing (VERY IMPORTANT)
- Q. UCC-3 Collateral Text Sample Take Note that You can create your Own Document Numbers for your paperwork. Below is a Example of Collateral Text you can use on your UCC 3.
