I checked his AKC records and discovered I was wrong by 1 point. He only needed 11 not 12 points.

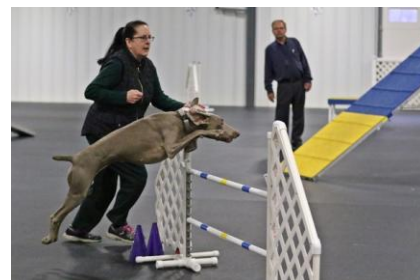
I had an experienced person review the record Tuesday evening to confirm this, she did. Thus, on 5 January 2020 Nachtisch earned his Grand Champion Title.

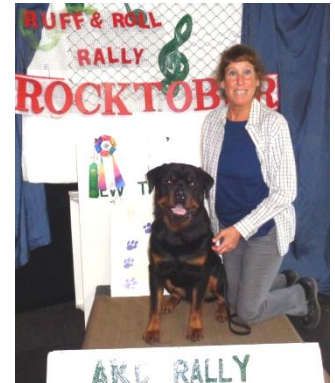

Congratulating Karen Mikulin & Victor on a History-making 2019

After the 2019 AKC Agility rankings had been processed, it was clear that 2019 had been a history-making year for Agility Rhodesian Ridgebacks!

In the AKC Agility 20" Preferred rankings for Rhodesian Ridgebacks, Victor, owned and handled by Karen

Mikulin, earned the top ranking. This was Karen and Victor's second consecutive year as the #1 Ridgeback team in the Preferred classes. And—after I spent much time examining all the available online ranking publications (end-of-year AKC Agility statistics and Bad Dog Agility Breed Power Score rankings)—I am quite certain that Victor made history in 2019 by becoming the very first Ridgeback to earn the title of PACH3!

Both Victor's ranking and his 3 PACH titles are even more remarkable given the fact that, due to her work schedule, Karen is limited to competing with Victor only on Sundays.

Additionally, because Victor only started competing in Agility at the relatively older age of 5 years old, his top rankings and PACH titles have all been earned in his Veteran years!

I feel very lucky to often be at the same Agility trials as Victor and Karen, as it is truly a pleasure to watch this team run.

Interested in being more involved in the agility program at YABTC? We have a few job openings for motivated people!

- Scheduling Workers

We need someone to put together the worker schedules for our agility trials. We only have 1-ring trials so this task is not as daunting as the 2-ring trials used to be!

- Timers for the agility trials

Rally Regulations – Editorial Clarifications

The newest Rally Regulations book has a pink cover and is dated February 1, 2019. The date is correct. This newest book is a reprint of the previous book. Listed below are the judging editorial clarifications.

Chapter 1

Section 15. Transfers. Transfers may be approved provided the class is **scheduled**, the judge is available, and the class has not reached its limit.

Section 16. Entry Eligibility, Change of Entry.
(added at the end of this section) **Judging
Procedures Regarding Eligibility.**

When the eligibility of a handler or dog to compete is in question, the matter should be referred to the Event Committee. When the Event Committee determines, from the information available, that a dog or a handler is ineligible to compete in the class, the handler is to be informed of the requirement of the AKC Rally Regulations that make him/her ineligible to compete. If any alternative exists (such as substituting an eligible handler to replace the handler who is ineligible to take the dog into the ring), it should be suggested. If the handler insists on competing, regardless of their or the dog's eligibility, then it is the duty of the secretary or superintendent to point out to the handler that the judge will be requested to judge the dog "under protest," and the dog or handler's eligibility to compete will be reviewed by the AKC.

The secretary or superintendent should inform the judge of the situation, requesting that the dog and handler be permitted to compete. The judge then permits the dog to compete. Judges are required to make a notation in their Judges' book when they encounter a situation where an exhibitor or dog is not eligible to show under them at an event. This report should give identifying information on the exhibitor and dog and a brief statement as to why, in the opinion of the judge, the handler or dog was ineligible. It is the responsibility of the trial secretary or superintendent to provide a concise, factual statement of the problem in the official AKC show/trial report. The AKC will make a determination based on what has been reported. If it is

determined that the dog is not eligible, the dog's score will be disallowed.

Section 19. Disturbances. The judge must **release** any dog that is not under its handler's control and any handler who willfully interferes with another competitor or that competitor's dog.

Chapter 2

Section 8. Judge's Book and Score Sheets. (at the end of this section) *Copies of the sheets in the official judge's book will be made available through the superintendent or show or trial secretary for examination by handlers immediately after the ribbons have been awarded in each class.*

Section 15. Collars. (second sentence) **No dog may enter the ring, either for judging or for awards, with unacceptable equipment.**

Section 19. Misbehavior. The handler is required to enter and exit the ring with the dog under control and without jumping, pulling or tugging on the leash. Any display of fear or nervousness by the dog must be penalized according to the seriousness of the misbehavior, whether it occurs during or between a sign or before or after judging. The penalty for misbehavior will be deducted from the total score. The judge may release the dog from further competition in the class. **A dog must be released for uncontrolled behavior such as excessive barking or running away from its handler.**

Section 22. Placement of Signs. (middle of the second paragraph) **The sign for #103 Send over Jump may be placed on the jump or to the right of the handler's path.** The duplicate signs made available for 206, 207, 208, 209, 311, 317 and 318, **will** be paired with the sign holder on the backside of the original sign. Directional signs for 306A, 307A and 308A **will** be paired with the sign holder on the backside of the original sign.

Performance of the sign must be near the designated sign unless otherwise stated in these Regulations.

Section 23. Sign Descriptions and Additional Information.

- **#298 - Sit Stay:** (middle of the second paragraph) The handler will then walk **forward** at least fifteen (15) feet to get the leash and return to heel position by walking around behind the dog.
- **#301-303 (301A-303A):** Handlers are not required to halt at the sign for these jumps, they may halt prior to or after the sign. The handler is not required to walk to a specific

location on the other side of the jump to call the dog. These distances, and the path each handler takes to get to the newly established line will vary. The handler must turn in the correct direction to avoid an IP penalty, but not at a specific location.

Glossary of Rally Terms:

Finish – the dog moves smartly **towards or to** heel position

Released – a dog must be released if it is not under the handler's control. A dog may be released from competition in the class for misbehavior.

AKC Rally Signs and Descriptions

The following sign descriptions were edited: **108** the distractions will be one or the other, dog safe toys or securely covered containers with tempting dog treats; **119 & 120** the word "and" was removed; **214 & 215** the word "together" was added; **314** now includes the additional diagrams, and **322** the word "then" was removed.

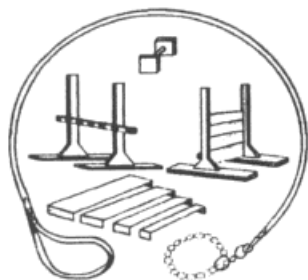
Plan on arriving no later than 11:30 AM as Sunday Agility Practice ends at Noon.
