(2) The fund has adopted a managed distribution plan (the "Plan") and employs an option over-write policy to support a level distribution of income, capital gains and/or return of capital. **The fixed amounts distributed per share are subject to change at the discretion of each Fund's Board of Directors/Trustees.**

Under its Plan, each Fund will distribute all available investment income to its shareholders, consistent with its investment objectives and as required by the Internal Revenue Code of 1986, as amended (the "Code"). If sufficient investment income is not available on a monthly basis, the Funds will distribute long long-term capital gains and/or return capital to their shareholders in order to maintain a level distribution.

(3) The Fund has distributed more than its income and net-realized capital gains in the current fiscal year; therefore, a portion of the distribution is return of capital.

The Fund sends shareholders a 1099-DIV that indicates how distributions should be reported for federal income tax purposes.

(4) BKT has adopted a Plan whereby beginning August 2018 the Fund will make fixed monthly distributions to common stockholders and will distribute all available investment income

to its stockholders, consistent with its investment objective and as required by the Code. **The fixed amount distributed per share is subject to change at the discretion of BKT's Board of Directors.**

If sufficient investment income is not available on a monthly basis, the Fund will distribute long term capital gains and/or return capital to its stockholders in order to maintain a level distribution.

The Fund is currently not relying on any exemptive relief from Section 19(b) of the Investment Company Act of 1940, as amended (the "1940 Act"). The Fund expects that distributions under the Plan will exceed current income and capital gains and therefore will likely include a return of capital. BKT may make additional distributions from time to time, including additional capital gain distributions at the end of the taxable year, if required to meet requirements imposed by the Code and/or the 1940 Act.

**The amounts and sources of distributions reported are only estimates and are not being provided for tax reporting purposes.**

The amount distributed per share under a Plan is subject to change at the discretion of the applicable Fund's Board.

Each Plan will be subject to ongoing review by the Board to determine whether the Plan should be continued, modified or terminated.

The Board may amend the terms of a Plan or suspend or terminate a Plan at any time without prior notice to the Fund's shareholders if it deems such actions to be in the best interest of the Fund or its shareholders.

The amendment or termination of a Plan could have an adverse effect on the market price of the Fund's shares.
