A BUYER may engage the services of an INDEPENDENT CONTRACTOR to have a PURCHASE ORDER structured by a MASTER CENTER (designated by TEXAS HOLDINGS, INC) and issued to TEXAS HOLDINGS, INC, <u>offering to pay 225%</u> of the prices charged by the vendors to the SUPPLIER.

The PURCHASE ORDER may include items and services requested by the BUYER (at 225% of prices charged by the vendors) and may include equal value of ADVERTISING CREDITS (at 25% of their face value) purchased from TEXAS HOLDINGS, INC.
