Exclusions:

- 5) This Warranty is expressly limited to manufacturing defects and does not include any damage or defect caused in any manner after your purchase of this product.

In the Event of a Warranty Claim:

- a) You must provide written notice of your claim within 30 days of when you discovered the defect or should have discovered the defect in the ordinary course of due care;
- b) You must provide Totally Bamboo with a reasonable opportunity to inspect or examine the defective or nonconforming Totally Bamboo product before you undertake any repair, removal, or replacement of the product;
- c) Your failure to comply with this requirement will void your Warranty coverage.
- 11) Following receipt of a Warranty claim, Totally Bamboo, at its sole option and discretion, shall provide conforming Totally Bamboo product to replace any defective Totally Bamboo product; alternatively, Totally Bamboo reserves the right to refund the percentage of the purchase price equal to the percentage of the Warranty period remaining as of the date of receipt of the Warranty claim for the defective Totally Bamboo product.
