Office 365 is an annual subscription that includes premium versions of the Office apps across all your devices, monthly exclusive feature updates, and 1TB of cloud storage per user.

 - Visio Professional 2019 for \$14.99
 - Project Professional 2019 for \$14.99
- 2. How do I make all the Home Use Program offers available to my employees?
 - Office Professional Plus 2019, Office Home and Business for Mac 2019, Visio Professional 2019 and, Project Professional 2019 offers
 - Until May 13, 2019: The current process will be available for you to manage these offers through the Volume Licensing Service Center (VLSC) and your employees can continue to claim these offers on www.microsofthup.com.
 - Starting May 13, 2019: You will have to transition the management of these
 offers from VLSC to the Microsoft Store for Business (MSfB) following the steps
 covered in question 3 below.

It is highly recommended that you start the process of setting up your account in MSfB right away to seamlessly transition to the new platform by May 13, 2019.
