Description

Recent regulations introduced by the Financial Adviser Standards and Ethics Authority (FASEA) now require all new financial planners to have an approved degree, and existing practising financial planners to update their credentials with a FASEA approved qualification by 2024.

Our Master of Financial Planning is designed for both. The Australian financial planning industry is growing fast, with one of highest rates of employment and strong future employment growth predicted for the next five years.

By studying a Master of Financial Planning, you'll gain the knowledge and skills needed to provide tailored, professional financial advice while navigating complex financial matters and ever-changing industry regulations.

Course structure

Our Master of Financial Planning offers flexible study options, including day and evening classes delivered through a combination of face-to-face and online.

You'll complete 12 core units that will help you meet the needs of the changing financial planning industry, including Elements of Financial Planning, Corporations and Contract Law, Investment Decision Making, Superannuation and Retirement Planning, Taxation Planning and Ethics and Client Management.




