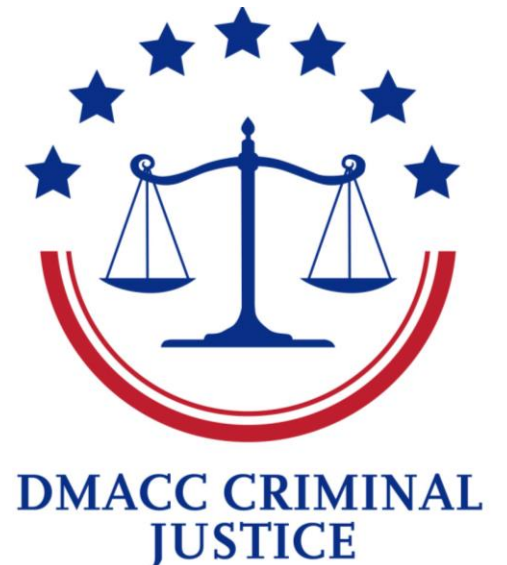


Assignment Rules and Proper APA Formatting

Plagiarism (please see course syllabus)

- Plagiarism is “the appropriation of and use of another person’s writing and passing it off as the product of one’s own efforts or copying any work and submitting it as original work.”
- Plagiarism is Considered Cheating
- Plagiarism Has These Potential Sanctions:
 - A Failing Assignment Grade
 - Failing the Whole Course
 - Suspension From College

Writing Assignments: What to Use and What Not to Use

Websites to Use:

- Appropriate Government and Reputable Organizational Websites
- Reputable News Organizations Websites
- Peer-Reviewed Scholarly Articles from Colleges and Universities

Websites NOT to Use:

- Wikipedia.com
- Encyclopedia.com
- Britannica.com
- Prezi.com
- History.com
- Other Similar Websites

Identify the Source of Information in Your Writings

- You Can Summarize, Consolidate, Paraphrase or Streamline Another Author's Writings, But You Must Identify the Source of Where You Found the Information.
- Use the American Psychological Association (APA) Format to Cite Your Sources
- Here is an Example of an APA Book Citation:

Ronczkowski, M. (2018). *Terrorism and Organized Hate Crime: Intelligence Gathering, Analysis, and Investigations*. Taylor & Francis Group.

In-text Citations

- You Must Also Use APA In-text Citations in Your Writings.

- Here is the In-text Citation for the Previous Book:

(Ronczkowski, 2018)

- Subsequent In-text Citations for the Same Book in the Same Writing Assignment Should Identify the Page Number Where the Information was Found:

(Ronczkowski, pg. 127)

Quotation Rules

- If you must use a quote, figure, statistic, phrase, or sentence from any resource, including your course textbook, it must be placed in “quotation marks” and properly cited with an in-text citation like (Ronczkowski, 2018) and with a properly formatted citation at the end of your writing.
- Quoted material should be not longer than one sentence.

APA Citation for a Website Should Include

1. Author
2. Date
3. Title of Article
4. Name of Website
5. URL

Exceptions

- If There is No Author, Then the Title of the Article is Listed First

Where Angels no Longer Fear to Tread. (2008, March 19). The Economist. <https://www.economist.com/science-and-technology/2008/03/19/where-angels-no-longer-fear-to-tread>

- If There is No Date Listed, Then Use (n.d.) as the Date

Author. (n.d.). *Title of specific document.* URL of specific document

Exceptions Continued

- If There is no Author and the Source is a Government Agency or an Organization, Then the Agency or Organization is Listed First

APA 7th Edition: What Has Changed?

- If There is no Author and the Source is a Government Agency or an Organization, Then the Agency or Organization is Listed First

APA 7th Edition: What Else Has Changed?

- When Citing Websites, “Retrieved From” is No Longer Needed

Walker, A. (2019, November 14). *Germany avoids recession but growth remains weak*. BBC News. <https://www.bbc.com/news/business-50419127>

- For Books, the Publisher Location is No Longer Needed

Covey, S. R. (2013). *The 7 habits of highly effective people: Powerful lessons in personal change*. Simon & Schuster.
