# **Introduction**

Outfitting business for sale. Located near the town of Bondurant, Wyoming, is Green River and Bridger-Teton Outfitters. This year-round business operates under Special Use Permits from the Bridger Teton National Forest. With two permitted camps, operations include world class big game hunting, blue ribbon trout fishing, and back country horseback adventures. The permits consist of 350 service days for pack trips, day rides, and hiking in the summer months. Fishing on the Green and New Fork Rivers is unlimited. There are 220 service days for hunting during the Spring and Fall, and 400 service days for snowmobile operations through the winter.

Northern Wyoming's wildlife is unmatched anywhere in the Rocky Mountain West. Hunt species include trophy elk, mule deer, pronghorn (antelope), bear, moose, mountain lion, wolves, and big horn sheep. Unlimited guided fishing on the Green and New Fork Rivers, and a variety of mountain streams, is phenomenal with rainbow, brown, cutthroat, brook trout. Bridger Teton National Forest encompasses more than 3.4 million acres with, towering mountain ranges, alpine meadows, aspen groves, creeks and rivers filled with trout. The permitted areas for Green River and Bridger - Teton Outfitters covers tens of thousands of acres, of prime wildlife habitat, and exceptional scenery.

This is a turn-key business with an extensive inventory of camping equipment, saddles, tack, trucks, trailers, horses, and snowmobiles. The quality of hunting, fishing, scenery, wildlife, and snowmobiling cannot be over stated. For qualified buyers this is a chance to own one of the finest, year-round outfitting operations in Wyoming.



#### **US Forest Service Permits**

Green River and Bridger-Teton Outfitters operates with Special Use Permits issued by Bridger Teton National Forest. Permitted operations include, horseback riding, pack trips, guided fishing, hunting and snowmobiling. There are two permitted camps within the National Forest, which can be accessed by UTV or horseback. The Craig Cabin Camp has two cabins built by an unknown trapper in 1898. The cabins are listed on the National Register of Historic Places. This camp is set up in the Spring and utilized through the Summer season, hunting season, and snowmobiling operations in the Winter months. The Dell Creek Camp is set up in August and utilized for hunting through the Fall.









# **Aerial Map**

# **Hunting**

# **Fishing**

Unlimited guided fishing on the Green and New Fork Rivers, and a variety of mountain streams, is phenomenal. Brown trout make up the vast majority of trout found in the New Fork River, and all of them are naturally produced. Anglers will also occasionally catch rainbow trout and cutthroat trout. The Green River supports a diverse fishery. Species include, brook, brown, cutthroat and rainbow trout, as well as, kokanee salmon, whitefish, and the occasional lake trout.





# **Horseback Riding**

Permitted in the Bridger Teton
National Forest and Wyoming's
famous Gros Ventre Wilderness,
the horseback riding available to
Green River and Bridger – Teton
Outfitter is unsurpassed
anywhere in the Rocky Mountain
West. Current operations include
two-hour rides, half day, full day,
progressive pack trips, and multiday overnight trips from the
Craig Cabin Base Camp.



# **Snowmobiling**

With 400 permitted service days, the Green River and Bridger – Teton Outfitters snowmobiling operation encompasses 350 miles of trails in remote areas of the eastern front of the Wyoming Range and Bondurant Basin. With spectacular views of the Sawtooth Mountains, time and time again snowmobile guest have said the quality of the experience with GRBTO far surpassed winter snowmobile trips in Yellowstone National Park. The business offering includes snowmobiles, clothing and gear.







#### **Permited Camps**

Green River and Bridger – Teton Outfitters has two permitted camps. Accessible only by UTV or horseback the Craig Cabin Camp is listed on the National Register of Historic Places. This camp is set up in the Spring and is utilized through hunting season and snowmobiling through the Winter. The Dell Creek Camp is set up in August and used through hunting season. Both camps are in remote spectacular settings.
