Below is a list of scholarships applicable to international MBA students. Please click on the scholarship organization to visit their web site.

General International Scholarships

The Aga Khan Foundation accepts applications from nationals of the following countries: Bangladesh, India, Pakistan, Afghanistan, Tajikistan, Kyrgyzstan, Syria, Egypt, Kenya, Tanzania, Uganda, Madagascar, and Mozambique. The Foundation gives priority to requests for Master's level courses. Applications must show consistently excellent academic records, genuine financial need, admission to a highly reputable university or program of student and relevance of the field of study to AKDN's focus areas. Amount of award is 50% scholarship/50% loan.

<u>The American Association of University Women</u> offers fellowships ranging from \$18,000-\$30,000 to female international students studying in the United States. Some fellowships are available for minority women who are U.S. citizens or U.S. permanent residents.

<u>The American-Scandinavian Foundation (ASF)</u> offers funding to Scandinavians to undertake study or research programs in the United States for up to one year. Also, the ASF offers fellowships and grants to individuals to pursue research or study in one or more Scandinavian countries for up to one year. Applicants must be US residents or permanent residents and have a well-defined research or study project that makes a stay in Scandinavia essential.

<u>Davis-Putter Scholarships</u> Need-based grants (up to \$6,000) to undergraduate or graduate students actively working for peace and justice on campus and/or in the community.

<u>Echoing Green Foundation Fellowships</u> Seeks to provide seed funding and support to more than 450 social entrepreneurs with bold ideas for social change in order to launch groundbreaking organizations around the world.

<u>Financial Women of San Francisco</u> As of 2018, FWSF has awarded over \$2.5 million in scholarships over the past 30 years to more than 300 Bay Area women. The FWSF Scholarship Fund provides graduate and undergraduate scholarships to San Francisco Bay Area women pursuing careers in finance and financial services. Beyond financial support, FWSF scholarship recipients have the opportunity to be mentored by FWSF members and attend career development and networking events.

<u>Fulbright Scholarships for Non-US Citizens</u> Fulbright awards are designed to promote international education and provide funding for US students abroad and international students in the US.

<u>G2 Entrepreneurial Scholarship</u> offers \$5,000 to six students who exemplify an entrepreneurial spirit and mindset. Applicants must be enrolled full-time.

<u>Humane Studies Fellowships</u> For undergraduate and graduate students interested in the classical liberal/libertarian tradition of individual rights and market economies. More than 100 fellowships up to \$15,000 are awarded annually.

<u>The International Education Financial Aid</u> web site provides college scholarship and loan information for international students wishing to study abroad.

<u>MPOWER Financing</u> celebrates international and DACA students, who enrich college campuses with their diverse experiences and points of view. MPOWER awards four \$5,000 scholarships to international and DACA students who are studying or plan to study in the US.

<u>OPEC Fund for International Development (OFID) Scholarship</u> provides an annual scholarship award to support a student from any developing country to pursue higher education in a relevant field of development. Winners of the OFID Award receive a full scholarship covering academic fees and living costs for one year of master's degree study.

The Orbis Investment Management Fellowship is a cash award attributable towards tuition or course-related expenses



for an exceptional, soon-to-be first-year MBA student, from any background, with any experience, who can demonstrate his or her talent and passion for investing.

The P.E.O. International Peace Scholarship Fund for Women is open to women from countries other than the U.S. and Canada. The candidate must be accepted full time to an accredited U.S. institution and must be working towards a graduate degree. Candidates must also promise to return to their country of origin within 90 days of completing the degree program to pursue a professional career. Awards up to \$6,000.

The Paul and Daisy Soros Fellowships for New Americans is a maintenance grant and tuition support for naturalized citizens or permanent residents who retain loyalty and a sense of commitment to their country of origin as well as to the United States and will continue to regard the United States as their principal residence and focus of national identity. Each fellow receives up to \$90,000 in financial support over two years.

<u>TY Danjuma MBA Scholarship</u> provides financial support to post-graduate African students who have been accepted into MBA programs at the top-10 leading Business Schools in the world.

<u>UNCF Scholarships and Grants</u> A series of scholarships which hold their own eligibility criteria, open/close dates and required documents. In order to apply for a UNCF Program Services Scholarship, you must apply through the online application process.

Armenia

<u>The Luys Foundation</u>: The Luys Foundation provides scholarships allowing Armenian students to study at the world's top universities. Scholars must show ambition to contribute to society, while demonstrating integrity of character, interest in and respect for others, and the ability to lead. Students applying to the Luys Foundation must be Armenian, Citizens of Armenia or of Armenian descent.

Australia

American Australian Association promotes educational exchange between the United States and Australia. The American Australian Association awards fellowships to Australians for advanced research and study in the United States. American Australian Association also awards US fellows to pursue studies in Australia.

<u>The General Sir John Monash Award</u>: Open to Australian citizens and graduates of universities in Australia who undertake study abroad. The General Sir John Monash Award is a prize of AUD \$50,000 for academic excellence and demonstrated leadership and potential. Awards are targeted more to PhD studies, however, in exceptional circumstances; applications from those commencing an MBA are also reviewed

Belgium

Belgian American Education Foundation: Fellowships for MBA or similar Management degree.

Brazil

<u>Coordination for the Improvement of Higher Education</u>: To complement the efforts of graduate courses in Brazil, Capes grants scholarships abroad, thereby fueling the academic and research means the country with human resources high level. The fellowships abroad are coordinated by the Directorate of International Relations (DRI).

<u>The Fundação Estudar Scholarship</u> is for Brazilian students who demonstrate high intellectual potential. Multiple scholarships are awarded each year, many to students studying business.

Canada

<u>Organization of American States (OAS) Fellowships Programs</u>: For Canadian citizens or permanent residents, the OAS scholarship provides tuition, benefits, and administrative costs not to exceed US \$30,000.

<u>The Canadian Federation of University Women (CFUW/FCFDU)</u> The Federation promotes higher education for women through its Fellowships and Awards Program.

Colombia

<u>Colombia Colfuturo Scholarship Program</u>: For Colombian students studying abroad in graduate educational programs. Award is a maximum of \$25,000 per year and a maximum two year stay abroad. Students must agree to return to Colombia within one year of finishing their programs.

Ecuador

<u>Becas SENESCYT</u> (Secretaria de Educacion Superior Ciencia, Tecnologia e Innovacion) offers government sponsored scholarships for undergraduate and graduate studies.

Finland

<u>Finland Foundation:</u> Full-time undergraduate and graduate students of all academic disciplines who are currently enrolled in accredited post-secondary schools in the United States and Finland are eligible for FFN scholarships.

<u>The League of Finnish-American Societies</u>: scholarships are intended for citizens of Finland in programs of study for economics and technology and humanities, sciences and culture in post-graduate studies and or research at American universities and colleges.

France

The French-American Chamber of Commerce Serge Bellanger Scholarship Program provides scholarships to French



students attending an MBA program in the United States.

Georgia

<u>The Ministry of Education and Science of Georgia</u> offers scholarships to students with good academic performance and admitted into one of the universities on the ministry's list.

Hungary

<u>Hungarian-American Enterprise Scholarship Fund</u>: The Hungarian-American Enterprise Scholarship Fund's (HAESF) offers a \$25,000 graduate scholarship for Hungarian citizens wishing to study in the United States.

India

<u>IN Tata Endowment for the Higher Education of Indians</u>: Awards a one-time loan scholarship only at the beginning of the course to Indian nationals for full time Postgraduate/Ph.D./Postdoctoral studies abroad and in India, in all fields, irrespective of caste, creed, gender or community. The selected scholars may also qualify for a gift scholarship and travel assistance.

<u>KC Mahindra Education Trust</u>: Since 1956, K. C. Mahindra Education Trust has granted interest-free loan scholarships to deserving students to pursue post-graduate studies abroad in various fields.

Indonesia

<u>The Putera Sampoerna Foundation</u> offers scholarship funds to outstanding young Indonesian citizens. The scholarship covers tuition, living expenses, and airfares to and from Jakarta.

Italy

<u>The John R. Mott Scholarship Foundation</u>: Students native to the Calabria region of Italy are eligible to apply for a scholarship to assist their education at any institution of higher learning.

<u>The Nova Scholarship</u> is awarded to Italian candidates who demonstrate academic and professional excellence. The grant, co-financed by the Italian branch of the Boston Consulting Group, will be awarded for the 2 year MBA program to cover part of tuition and fees. Japan

<u>Japan-IMF Scholarship Program for Advanced Studies</u>: Nationals of IMF Asian member countries interested in studying for their doctorates in economics in order to work in an international financial institution (such as the IMF or the World Bank) or in their home administrations.

<u>JA Study Abroad Center</u> provides information about available scholarships for Japanese students who wish to study in the United States.

Korea

<u>Samsung Scholarship</u> offers scholarships to finance Korean nationals studying abroad. The scholarship covers tuition and living expenses up to \$50,000 each year.

<u>The Kwanjeong Educational Foundation</u> selects Korean citizens each year who have gained or are seeking admission to leading universities outside of Korea. The scholarship covers up to \$55,000 per year.

Latin America

<u>Leo Rowe Fund</u>: The Rowe Fund is an educational loan program of the Organization of American States (OAS) that helps citizens from Latin America and Caribbean <u>OAS Member States</u> finance their studies or research in accredited universities across the United States by awarding interest-free loans of up to US\$15,000 dollars.

Lebanon

Lebanese International Finance Executives (LIFE) is a non-for profit membership organization providing a platform



to channel the influence of Lebanese Finance Executives worldwide in order to establish stronger bonds, nurture the next generation and promote Lebanon. The LIFE scholarship provides support to talented Lebanese students – or those of Lebanese descent – with financial needs, to pursue their academic aspirations in the field of finance. It is a unique combination of financial support and mentorship opportunity by a LIFE Senior Member who will provide guidance and advice to the scholars on their professional objectives.

Mexico

<u>Conacyt Scholarship:</u> Scholarships for Mexican professionals who wish to pursue graduate studies in science and technology, social and humanistic quality in an institution recognized overseas areas.

Norway

AKER Scholarship is a grant awarded to students who want to apply for Master's or PhD studies. The Scholarship is open for all fields of study, but you can only apply if you are not already enrolled in the program. To be eligible you must be Norwegian or have a strong link to Norway: you must have lived in Norway for several years and speak Norwegian.

Peru

<u>PONABEC</u> (Programa Nacional de Becas y credito educativo) offers divers scholarships (such as Beca Presidente de la Republica) and student loans for the training and specialization of human talent in the country and abroad.

Spain

<u>Fundación La Caixa</u>: La Caixa is the biggest saving bank in Spain. It offers 225 scholarships to study postgraduate courses in Spain and abroad (either masters or PhDs); 45 are specifically earmarked for the U.S. The funds are awarded on a merit basis and cover tuition and fees, living and traveling expenses, health insurance and visa costs.

<u>Fundacion Rafael Del Pino</u> offers 15 scholarships to Spanish students to help create the next generation of Spanish leaders. Educational areas of interest to the foundation are: economy and company; economic analysis of the right; regulation and deregulation and economic analysis; and legality of competition and the markets.

<u>Fundacion Ramon Areces</u>: Offers Spanish students an Economia y Derecho de la Union Europea scholarship for graduate business students abroad. The foundation sponsors scholarship programs for studies abroad to enable Spanish post-graduate students to study at some of the world's leading research centers.

<u>Talentia Scholarships</u>: Aimed at identifying those young Andalusians whose intellectual/human excellence and leadership potential have given them the capacity to contribute to the future development of Andalusia.

United Kingdom

<u>The James and Mary Dawson Scholarship</u>: St. Andrew's society of Washington D.C. awards several \$5,000 scholarships for Scots coming to the USA for graduate or post graduate study.

The Sainsbury Management Fellowship Scheme: Fellowships for UK Citizens with an engineering background.

<u>The UK Fulbright Scholarship</u> offers awards to students who aim to increase mutual understanding between the peoples of the United Kingdom and the United States, through the exchange of persons, knowledge, and skills.
