- 4. A registered user is responsible and liable for any documents submitted electronically to the System by means of the user's login and password.
- 5. A registered user's System eligibility may be restricted or revoked for any of the following reasons:
 - knowingly permitting his/her System password to be utilized by anyone who is not authorized to utilize the password
 - filing documents on behalf of someone who is not a registered user
 - failing to comply with any of his/her other obligations set forth in this agreement.
- 6. I understand that, if I am a provider of a post-petition instructional course concerning personal financial management and I am filing a certificate of the debtor's completion of the course, the certificate must be timely filed in accordance with Fed. R. Bankr. P. 1007(c).
