

ILLINOIS GED® RECORDS

Illinois GED records are located at (and Verifications, Transcripts and Certificates are issued by) the Regional Offices of Education* (ROE), so you must first determine the correct ROE to contact.

- If the test was completed prior to January 1, 2014 (and was not taken on computer), contact the ROE* for **the county where the test was taken**.
- If the test was completed after December 31, 2013 (or was taken on computer in 2012/2013), contact the ROE* for the **county of residence** at the time of test completion.

*The [Cook County HSE Records Office](#) acts as the GED custodian of record for Cook County.

Once you know the appropriate county, you may select it from the list below to obtain contact information for that office.
