#### **DIVIDENDS DECLARED**

For share accounts, LZECU Board of Directors approved a 0.55% APY\* dividend for the 3rd quarter 2014. You must maintain a minimum daily balance of \$25 to earn the APY\*. Share dividends are paid on the 1st day of each quarter.

Share draft accounts will earn 0.15% APY\* for the 4th quarter 2014. You must maintain a minimum daily balance of \$300 to earn the APY\*. Share draft dividends are paid monthly on the 1st.

Individual Retirement Accounts (IRAs) will earn 0.80% APY\* for the 4th quarter 2014. IRA dividends are paid monthly on the 1st.

\*APY is Annual Percentage Yield. Dividends are calculated on a day-in-day-out basis. Rates are subject to change without notice. Call for our Rate & Fee Schedule.

#### **Fraud Detection and Prevention: Behind-The-Scenes**

Lubrizol Employees' CU can help stop card fraud before it even happens

Lubrizol Employees' Credit Union utilizes a cutting-edge fraud-detection system that helps stop fraud at the point of sale for credit and debit card transactions. This sophisticated and highly effective system is the most reliable tool in the industry to help minimize your risk of fraud.

The system identifies certain typical situations in which card fraud can occur. If questionable activity is detected, the system compares the charge in question to your normal spending pattern and "scores" it based on the likelihood of fraud. If the system determines that there is questionable activity on the account, it is queued to an investigator who will contact you for verification of the charges. If fraud is confirmed, your account is closed immediately and a new account is generated for you.

It may turn out that it really was you making the purchase. But just as easily it could be that Lubrizol Employees' Credit Union has prevented you from being a victim of fraud.
