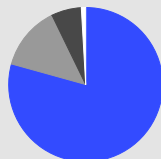

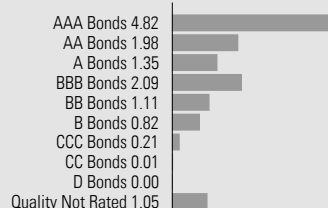

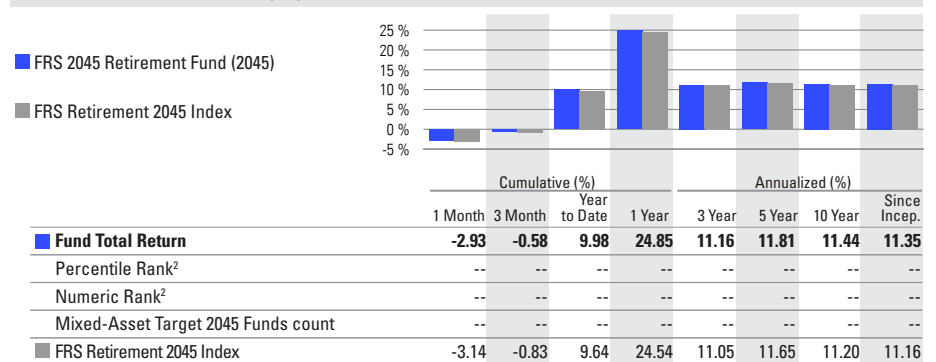

Historical Performance (%)

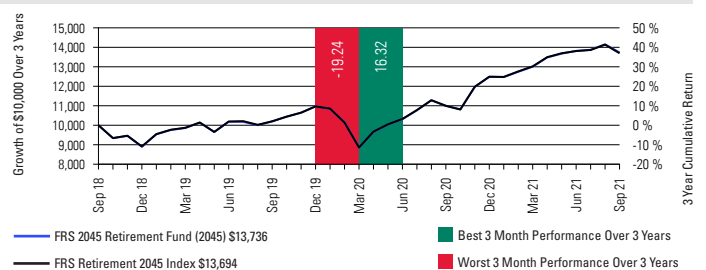

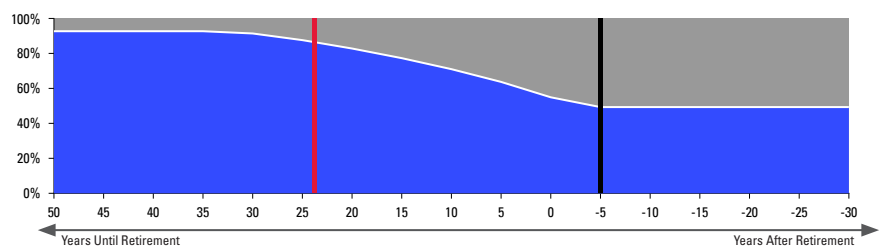

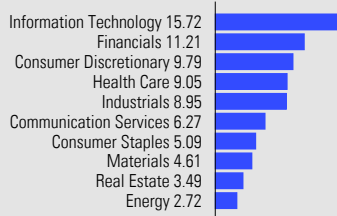

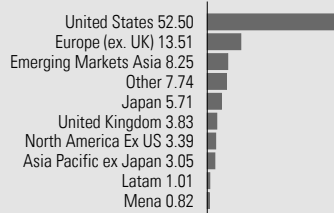
