I have been getting many questions about the different types of Case Management Certifications available. So I decided to create a side by side comparison of 3 of the available certifications to help you compare each certification type.

I wanted to share how I choose the CCM Certification from all the options.

At first, I was leaning toward the ANCC since I was a nurse and it was for nurses only. When it was time for me to apply, I asked the director of my department her opinion. Her answer was "the CCM is the gold standard"...

So, I began looking into CCM. I also looked at job postings for Case Manager positions I may want in the future and all the positions required CCM certification.
