**Position Title:** License Specialist

**Location:** Reno, NV

### **Summary**

The Nevada State Board of Medical Examiners (Board) is searching for a License Specialist for our Reno, NV office. This position is responsible for assisting individuals in obtaining and renewing licenses for the following professions: Physicians, Physician Assistants, Respiratory Care Practitioners and Perfusionists. The Board is looking for candidates that can provide excellent customer service while working in a fast-paced environment. Candidates need to be detail oriented and possess strong interpersonal skills.

This position is eligible for excellent employee benefits, including:
