<b>Salvage Inspection</b>		
<b>Required Fee</b>	<b>Fee Amount</b>	<b>Explanation</b>
Salvage Inspection Fee	\$35.00	Due for inspections of <u>salvage</u> vehicles only.
Expedited Processing	\$20.00	Optional fee, due only if customer requests expedited service.
State/Deputy Filing Fee	\$11.00	
<b>Transfer of Special Plate</b>		
Special Plate Transfer Fee	\$5.00	Fee due when transferring a special plate to another vehicle.
Filing fee	\$11.00	Fee may be due if the plate transfer is not done in conjunction with another transaction, such as title transfer.
